On February 21, 2017, the Commission's Staff filed a motion for a one week extension of time to file a recommendation regarding proposed changes to certain provisions of Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company's demand-side programs. Staff requests that the deadline be extended until March 1, 2017 due to its participation in simultaneous rate case proceedings. The Commission finds the request reasonable and will grant the motion.

THE COMMISSION ORDERS THAT:

1. Staff's Motion for One Week Extension of Time to File Recommendation is granted. The deadline for filing a Staff recommendation is extended until no later than March 1, 2017.

2. The deadline for any party wishing to comment on the application submitted by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company is also extended until no later than March 1, 2017.

3. This order shall be effective when issued.
