**THE OFFICE OF THE PUBLIC COUNSEL'S STATEMENT OF SUPPORT
FOR NON-UNANIMOUS AGREEMENT**

COMES NOW the Office of the Public Counsel (Public Counsel) and for its Statement of Support for Non-Unanimous Agreement states as follows:

1. On May 27, 2014, the Missouri Public Service Commission Staff (Staff), Kansas City Power & Light Company (KCP&L or Company), KCP&L Greater Missouri Operations Company (GMO), Missouri Division of Energy, Natural Resources Defense Council, Sierra Club, and Earth Island Institute d/b/a Renew Missouri (together, the "Signatories") filed a *Non-Unanimous Stipulation and Agreement Resolving Kansas City Power & Light Company's MEEIA Filing* (Non-Unanimous Agreement) with the Missouri Public Service Commission (Commission).
2. The Non-Unanimous Agreement states that as a result of extensive settlement discussions among all of the Signatories, the Signatories have agreed upon the terms and conditions included in the Non-Unanimous Agreement as a full and final resolution of all issues in this case.
2. Public Counsel, while not a Signatory to the Non-Unanimous Agreement, participated fully in the settlement discussions and in the preparation of the document that was ultimately filed with the Commission.

3. Public Counsel believes the Non-Unanimous Agreement provides a just and reasonable resolution to the issues in this case. Therefore, Public Counsel now states to the Commission that it supports the Non-Unanimous Agreement and requests that the Commission approve the Non-Unanimous Agreement as presented.

WHEREFORE, Public Counsel respectfully submits its statement of support.
