REQUEST FOR EXTENSION OF TIME TO FILE STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission, by and through the undersigned counsel, and for Staff's *Request for Extension of Time to File Staff Recommendation* ("Request") respectfully states:

1. On June 12, 2014, the presiding regulatory law judge issued, by delegation of authority, an *Order and Notice* in which he noted,

On June 11, 2014, KCP&L Greater Missouri Operations Company ("GMO") asked the Commission to approve its residential lighting program. At the same time, GMO filed a tariff that has an effective date of July 11. But GMO asks that the tariff go into effect on July 6 to coincide with Kansas City Power & Light's ("KCP&L") similar residential lighting program.

Staff notes that, in addition to adopting a residential lighting program, GMO's filing seeks to modify the GMO MEEIA program plan's cumulative annual energy and demand savings targets.

2. The *Order and Notice* also requires Staff to file a recommendation by no later than June 25, 2014.

3. During the course of its review and analysis of GMO's filing, Staff discovered errors in the filing and in the computations underlying it. Staff promptly informed GMO's representatives of the errors, and, as a result, GMO has represented to Staff that it will make a filing to correct the errors by the close of business on

Tuesday, June 24, 2014. Staff anticipates GMO will file corrected testimony, schedules, and tariff sheets.

4. Since GMO is not anticipated to file the corrections until June 24, 2014, and Staff's recommendation is due June 25, 2014, Staff will be unable to properly review and analyze GMO's corrections and prepare and file its Staff Recommendation on the ordered June 25, 2014, due date. However, Staff understands that GMO desires for the tariff sheet(s) which are part of this filing to become effective July 6 and is willing to work with GMO to attempt to make that happen. Therefore, Staff requests that the Commission give it until Friday, June 27, 2014, to file its recommendation. This is only a two-day extension of time to file the Staff Recommendation, and will still allow for the matter to be placed on the same Commission Agenda as the previously-ordered date would have allowed, namely the July 2 Agenda session.

WHEREFORE Staff, in anticipation of GMO correcting its filing by the close of business on Tuesday, June 24, 2014, respectfully requests the Commission, or the presiding regulatory law judge by delegation of authority, issue an order granting Staff a two day extension of time to file its Staff Recommendation in this matter, specifically until Friday, June 27, 2014.
