**ORDER APPROVING REQUEST TO  
REVISE TECHNICAL RESOURCE MANUAL**

On May 16, 2016, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") requested that the Commission approve revisions to its Technical Resource Manual (TRM). The Commission approved the TRM in its Order Approving Non-Unanimous Stipulation and Agreement on February 10, 2016.

Ameren Missouri states that additional measures should be offered to business customers. Ameren Missouri states that energy and demand savings and costs associated with these additional measures have been reviewed by the Implementation Team and its own implementation and evaluation contractors. Additionally, Ameren Missouri provided its proposed TRM revisions to MEEIA Cycle 2 stakeholders, and received no feedback. The measure changes have undergone a cost effectiveness analysis, and will not require any adjustment of the portfolio's goals.

Ameren Missouri included the proposed revisions with its application. The proposed revisions to the TRM:

- Add five new measures to Ameren Missouri's portfolio, four measures relating to lighting, and one measure incentivizing commercial use of smart thermostats;
- Update the TRM effective date to accommodate new measures; and
- Update contact information for relevant Company staff.

Commission Rule 4 CSR 240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered by the Commission. The Commission issued no order to the contrary, ten days have elapsed since Ameren Missouri's request, and no party has objected. Thus, the Commission will take up Ameren Missouri's request unopposed.

The Commission finds the request reasonable, and will grant it.

**THE COMMISSION ORDERS THAT:**

1. The Request to Revise Technical Resource Manual filed by Union Electric Company, d/b/a Ameren Missouri, is granted.
2. This order shall become effective on June 17, 2017.
3. This file shall be closed on June 18, 2017.
