**ORDER APPROVING APPLICATION TO MODIFY TECHNICAL RESOURCE
MANUAL AND PROGRAM DESIGN INCENTIVE RANGES**

Effective Date: April 20, 2018

On February 28, 2018, Kansas City Power and Light Company and KCP&L Greater Missouri Operations Company (collectively, the "Company") applied to the Missouri Public Service Commission ("Commission") for approval to modify the Company's Technical Resource Manual ("TRM") and Program Design Incentive Ranges. This request represents modifications to Appendix 1 and Appendix 2 of the *Non-Unanimous Stipulation and Agreement* ("Stipulation") in File Nos. EO-2015-0240 and EO-2015-0241, which was approved by the Commission on April 6, 2016, and the Company's existing MEEIA Cycle 2 TRM. The Commission set a deadline for a Staff recommendation and responses by other parties. Staff filed its recommendation on March 12, 2018, and no other parties filed a response to the Company's application.

Staff states that the proposed modifications in the application are primarily based on incorporating the Evaluation, Measurement, and Verification (“EM&V”) results for the Company’s MEEIA Cycle 2 program year 2016. The proposed modifications implement suggestions and feedback from the implementation team and the Company’s third-party EM&V contractor, Navigant Consulting, Inc. The TRM is being modified to update measures that will improve the accuracy of savings associated with those measures, allow for greater overall residential and business participation, and improve the efficiency of spend for the existing program budgets. The program measure incentive ranges are being modified wherever a new measure is added or wherever there is a need to lower the bottom of an incentive range to improve cost effectiveness. The Company is not asking for any modification to the currently-approved MEEIA Cycle 2 budgets or annual savings targets. Staff recommends that the Commission approve the modifications to Appendix 1 and Appendix 2 of the Stipulation and the TRM.

Based on its independent and impartial review of Staff’s recommendation and the Company’s unopposed application, the Commission concludes that the Company’s Application for Approval to Modify Technical Resource Manual and Program Design Incentive Ranges should be approved.

THE COMMISSION ORDERS THAT:

1. Kansas City Power and Light Company and KCP&L Greater Missouri Operations Company’s Application for Approval to Modify Technical Resource Manual and Program Design Incentive Ranges, filed on February 28, 2018, is approved.
2. Kansas City Power and Light Company and KCP&L Greater Missouri Operations Company shall file with the Commission an amended Appendix 1 and Appendix

2 to the *Non-Unanimous Stipulation and Agreement* described above and an amended Technical Resource Manual that incorporates all modifications approved by the Commission in this application.

3. This order shall be effective on April 20, 2018.
