**ORDER APPROVING EXPEDITED TARIFFS**

Issue Date: March 23, 2016

Effective Date: April 1, 2016

On March 2, 2016, the Commission issued a Report and Order that rejected tariff sheets previously filed by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (collectively, "Company"), but authorized the Company to file new tariff sheets in compliance with the Report and Order. On March 16, 2016, the Company filed revised tariff sheets and a *Motion for Expedited Treatment* requesting that the tariff sheets become effective on April 1, 2016. The tariff sheets carry an effective date of April 15, 2016, but the Company's motion for expedited treatment asks the Commission to approve the tariff revisions to take effect on less than thirty days' notice so that new energy efficiency programs can be implemented as soon as possible. The Company filed substitute tariff sheets on March 21, 2016.

The Commission ordered that any party wishing to respond to the Company's motion for expedited approval of its tariffs do so no later than March 22, 2016. The Commission also ordered its Staff to file a recommendation by that date. On March 22, 2016,

Commission's Staff filed its recommendation advising the Commission to approve the tariffs to be effective on April 1, 2016, as requested. No other party has filed an objection or response regarding the motion for expedited treatment or the tariff.

The Commission finds that the Company has demonstrated good cause to make the tariffs effective on less than thirty days' notice, since doing so will allow new energy efficiency programs to be implemented as soon as possible. Based on its independent and impartial review of Staff's recommendation and the Company's unopposed motion, the Commission concludes that the submitted tariffs should be approved on less than thirty days' notice.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff sheets submitted under Tariff Nos. YE-2016-0230 and YE-2016-0231, as substituted, by Kansas City Power & Light Company are approved, effective on and after April 1, 2016. The specific tariff sheets approved are:


