ORDER FINDING COMPLIANCE

Issue Date: December 16, 2015 Effective Date: December 29, 2015

The Commission is making its finding as to the triennial integrated resource plan ("IRP") for 2015 of Kansas City Power & Light Company ("KCP&L").

Filings

KCP&L filed its IRP¹ as required by the chapter of Commission rules on electric utility resource planning.² The Commission received a report from Staff ³ and comments from Natural Resources Defense Council ("NRDC"), ⁴ and Sierra Club. ⁵ KCP&L and Staff made a joint filing,⁶ for which Staff also separately provided information and explanation.⁷ In response to the Commission's schedule for further filings,⁸ the

Commission received a further joint filing from KCP&L and Staff, ⁹ and further comments from NRDC, ¹⁰ to which KCP&L filed a response. ¹¹

Findings

The Commission's regulations provide that the Commission will issue an order on the IRP, ¹² and that such order may find:

That the [IRP] does . . . demonstrate compliance with the requirements of this chapter, and that the utility's resource acquisition strategy . . . does . . . meet the requirements stated in 4 CSR 240-22. $[^{13}]$

The Commission will find that the IRP, and KCP&L's resource acquisition strategy, meet the requirements stated in 4 CSR 240-22.

THE COMMISSION ORDERS THAT:

1. As of December 16, 2015, the KCP&L Greater Missouri Operations Company (GMO) Integrated Resource Plan demonstrates compliance with the requirements of chapter 4 CSR 240-22; and KCP&L's resource acquisition strategy meets the requirements stated in 4 CSR 240-22.
