## STAFF RECOMMENDATION THE CASE MAY BE CLOSED

COMES NOW the Staff of the Commission and submits its Response to Missouri Gas Utility's *Response to Staff Recommendation and Memorandum* and Recommends this case may be closed.

- 1. On October 29, 2008, Missouri Gas Utility (MGU or Company) filed a tariff sheet to change in MGU's Purchased Gas Adjustment (PGA) rates. MGU sought an effective date of November 12, 2008.
- 2. Missouri Gas Utility, Inc. (MGU) is a Colorado Corporation, and a subsidiary of Summit Utilities, Inc., located in Littleton, Colorado. It serves communities in and around Gallatin, Hamilton, Jamesport, Ridgeway, and Pattonsburg, Missouri.
- 3. On May 5, 2009, the Commission Staff (Staff) filed its Recommendation and Memorandum in this matter. This document set out the results of Staff's audit of the billed revenues and actual gas costs for the period September 1, 2007 through August 31, 2008, included in MGU's 2007-2008 Actual Cost Adjustment (ACA) filing.
- 4. On May 11, 2009, the Commission issued its Order Directing Response wherein it ordered MGU to respond to the Staff Recommendation and Memorandum no later than June 10, 2009.
- 5. On June 10, MGU filed its *Response* and agreed with and accepted Staff's recommendations.

6. Staff is satisfied with MGU's response and recommends the Commission order MGU to establish the following ACA account balance in its next ACA filing to reflect the August 31, 2008 (over)/under-recovered ACA balance shown in the "Staff Recommended" column of the table below:
