On December 7, 2020, the FCC announced the winning bidders for the Rural Digital Opportunity Fund Phase I Auction (Auction 904) (“RDOF Auction”).³ CCO Holdings, LLC (“CCO Holdings”), an affiliate of the Charter Entities, was selected as a winning bidder in Missouri.⁴ CCO Holdings assigned its winning RDOF Auction bid in Missouri to Charter Fiberlink, which is the “lead operating company” with respect to such bid, and TWCIS must satisfy certain public interest requirements in connection with the bid.⁵ The Charter Entities’ receipt of RDOF Auction funding and building to these unserved areas, however, are conditioned upon them obtaining designation as ETCs in the Census Blocks where CCO Holdings was the winning bidder in Missouri.⁶ The Census Blocks associated with CCO Holdings’ winning bid are identified in **Exhibits A and B** (“RDOF Census Blocks”). A map illustrating the RDOF Census Blocks is attached as **Exhibit C**. Accordingly, Charter Fiberlink and TWCIS seek ETC designation in the RDOF Census Blocks in their respective service areas in Missouri so they may satisfy their FCC RDOF Auction requirements. Further, the Charter Entities seek a waiver of the pre-application notice required by 20 C.S.R. 4240-4.017(1), for the reasons explained below.

Section 214(e)(2) of the Act authorizes the Commission to designate a company that meets the requirements of 47 U.S.C. § 214(e)(1), such as each Charter Entity, as an ETC. As demonstrated in this Joint Application, each Charter Entity meets all requirements for ETC designation. Further, as shown by the descriptions herein, designating each Charter Entity as an ETC in its RDOF Census Blocks would allow the Charter Entities, either directly or through their

affiliates,⁷ to bring high-quality, innovative voice and broadband Internet access services to consumers in unserved portions of Missouri, advance the goals of universal service, and serve the public interest.

Ensuring that high-speed broadband service is available to those without access in the state has been a major priority of the Governor and its lawmakers. By granting this Joint Application, the Commission has the potential to bring significant public and private investment to Missouri and to advance the state's goals in making sure that more of its citizens have access to high-speed broadband Internet services. The FCC estimates that Missouri has more than 199,211 unserved residential and small business locations,⁸ and granting this Joint Application will help to lower that number substantially. While the Charter Entities, through other Charter affiliates, have participated in state programs to advance broadband buildout in Missouri, participation through RDOF presents a unique opportunity for Missouri to do substantially more to bridge the digital divide in unserved areas.

In support of their Joint Application, the Charter Entities state as follows:

I. OVERVIEW OF THE CHARTER ENTITIES AND CHARTER

Charter Entities. Each Charter Entity is a Delaware limited liability company with a place of business at 12405 Powerscourt Drive, St. Louis, Missouri 63131. Both Charter Entities are majority owned and wholly controlled subsidiaries of Charter Communications, Inc. ("Charter"), which is headquartered at 400 Atlantic Street, Stamford, Connecticut 06901. CCO Holdings and both Charter Entities are subsidiaries of Charter. A copy of each Charter Entity's registration with

the Missouri Secretary of State, including Certificate of Good Standing, is attached at **Exhibits D and E**. Both Charter Entities are authorized by the Commission to provide local exchange and interexchange telecommunications services in Missouri.⁹ A copy of each Charter Entity's authorization is attached at **Exhibits F and G**.

Charter. Charter is a leading broadband connectivity company, serving more than 30 million customers nationwide. Under the brand name Spectrum, the company offers a suite of advanced communications services, including broadband Internet access, cable video, voice, and mobile services.¹⁰ Through its subsidiaries, Charter provides these services in 41 states, including to approximately 769,000 customers in Missouri.

Helping to drive Charter's rapid growth is Charter's strong network investment which has significantly enhanced Charter's broadband Internet access service and allowed Charter to better serve its customers in both urban and rural communities across the United States. In 2018-2019, Charter extended its network to more than 1.5 million unserved homes and businesses, 30% of which were in rural areas. And from 2015 to 2019, Charter invested nearly \$40 billion in infrastructure and technology to expand the reach of its network.

Charter's customers directly benefit from Charter's commitment to and investment in its network. The FCC recently reported that Charter had one of the fastest, most consistent broadband Internet download speeds in the industry, including at peak times of the day when customer

Internet usage is the highest.¹¹ Additionally, recognizing Charter’s experience and commitment to its customers, its network, and its products, *Multichannel News* recently awarded Charter as its “Operator of the Year for 2020.”¹² With millions working and learning from home due to the COVID-19 pandemic, access to dependable, high-speed broadband Internet access services and reliable voice services has never been more important, especially in the unserved areas comprising the RDOF Census Blocks. Further, Charter’s network investment has spurred the development of products such as Charter’s Spectrum Mobile service, which relies on the use of the Verizon Wireless mobile network and Charter’s own broadband network infrastructure to provide fast, reliable broadband and voice services from customers’ mobile phones.

Charter is committed to being part of a comprehensive solution to close the digital divide throughout the United States. With more than \$1.2 billion in RDOF funding awarded to the company across the country, Charter plans to continue its efforts as a leader in rural broadband deployment, bringing innovative, high-quality voice and broadband Internet access service offerings to unserved communities. In Missouri, the more than \$48 million of RDOF funding assigned to the Charter Entities will help enable Charter to expand the availability of its network and services in the RDOF census blocks. In fact, according to the FCC, it assigned Charter the most locations of any provider that participated in the RDOF Auction.

Additional information discussing Charter's RDOF funding in Missouri is described at **Exhibit H**, which is being provided to the Commission in accordance with the Commission's requirements for confidential information.

A. RDOF Support Assigned to the Charter Entities Will Enable Charter to Extend Voice Services to the RDOF Census Blocks

Charter provides voice communications services to over 9.3 million residential customers throughout its 41-state footprint using interconnected Voice over Internet Protocol technology.¹³ Charter's voice service offering includes unlimited long distance calling in the United States, Canada, Puerto Rico, the US Virgin Islands, and Guam. Calling features include voicemail, call waiting, caller ID, call forwarding, and other features, at no additional charge. In addition, the E911 feature automatically provides the emergency service operator with a caller's phone number and location. With respect to its residential voice services, Charter offers customers a simplified pricing structure with plans that include all applicable fees¹⁴ – thus permitting such customers to know their total costs in advance of choosing Charter's services, rather than facing a variety of complicated surcharges after they receive their first billing statement.¹⁵

The RDOF support assigned to each Charter Entity will help enable it to extend and maintain Charter's voice services to and within its respective RDOF Census Blocks in Missouri.

B. RDOF Support Assigned to The Charter Entities Will Enable Charter to Extend Broadband Internet Access Services to the RDOF Census Blocks

Charter's broadband Internet access services deliver industry-leading speeds to the vast majority of its 26.8 million residential broadband Internet customers.¹⁶ Charter now offers minimum download speeds of at least 200 Mbps in 60% of Charter's national footprint, and 100 Mbps everywhere else in the footprint—including households and small businesses in rural areas. On December 17, 2020, Charter announced that it plans to double Charter's broadband Internet access service starting speeds in 17 U.S. markets, including areas in and around Columbia, Missouri, making 200 Mbps the starting flagship speed in 75% of Charter's communities. These speed enhancements will be available to new customers immediately. Existing customers will receive these speed increases with new Charter broadband Internet access service packages during the first quarter of 2021.¹⁷

Charter also offers a 1 Gbps connection with maximum download speeds of up to 940 Mbps to the vast majority of those same households, as well as to small and medium-sized businesses.¹⁸ Additionally, recognizing the need for fast, reliable broadband service for community anchor institutions, Charter offers 10 Gbps symmetrical speed broadband Internet connections to schools, libraries, hospitals, and other important community institutions.

The RDOF support assigned to each Charter Entity will enable it to extend Charter's broadband Internet access services to its respective RDOF Census Blocks in Missouri. The terms of the support assigned to each Charter Entity will require it to offer Charter's 1 Gbps connections in the RDOF Census Blocks. According to the FCC, these areas are currently unserved by any

broadband provider offering service at or above 25/3 Mbps. Granting this Joint Application will help extend broadband and unleash tremendous benefits to the communities within these RDOF Census Blocks. Charter's broadband deployment demonstrates its commitment to developing and deploying innovative broadband technology and services in unserved and/or rural areas. Additionally, Charter's services will provide new and innovative services to previously unserved customers in the RDOF Census blocks, including by providing relief to customers struggling as a result of the COVID-19 pandemic. It will allow students and households to get or stay connected, and expand broadband Internet access and adoption among low-income households.

As part of its current broadband Internet access service plans, Charter offers *Spectrum Internet Assist*, a program for low-income households, which is available in its service area in Missouri and elsewhere.¹⁹ Charter does not require customers to sign long-term contracts for its services nor does the company impose early termination fees for failing to fulfill them.²⁰ Charter maintains a focus on ensuring that the broadband user experience is a positive one.²¹

III. CHARTER'S PARTICIPATION IN THE RDOF AUCTION

A. **Background on the RDOF Auction**

On February 7, 2020, the FCC issued a Report and Order establishing the Rural Digital Opportunity Fund, in which service providers would compete to receive up to \$20.4 billion to offer voice and broadband services in unserved high-cost areas.²² Under this program the FCC will disburse federal universal service funds on a technology neutral basis to providers—including competitive local exchange carriers, cable operators, fixed wireless ISPs, satellite broadband providers, electric co-ops and electric utilities—for deploying voice and broadband-capable networks in these unserved areas.

B. **CCO Holdings' Selection as a Winning Bidder and Assignment to the Charter Entities**

The FCC's December 7, 2020 *Auction 904 Results Notice* announced that CCO Holdings was among the winners of the recently concluded RDOF Auction.²³ Specifically, the FCC announced CCO Holdings as a winning bidder in 8,406 Census Blocks in Missouri. In accordance with the FCC's procedures allowing winning bidders to divide and assign their bids to affiliated operating companies within the relevant state,²⁴ CCO Holdings assigned its winning RDOF Auction bid to Charter Fiberlink, who is the "lead operating company" with respect to such bid, and designated TWCIS to satisfy certain public interest requirements in connection with the bid. Each Charter Entity must demonstrate to the FCC that it has been designated as an ETC in its respective RDOF Census Blocks where CCO Holdings was the winning bidder in Missouri. The

FCC's deadline for the Charter Entities to submit appropriate documentation of their ETC designations is June 7, 2021.²⁵

C. Need for Expedited ETC Designation and Waiver of Pre-Application Notice Rule

As noted, On December 7, 2020, the FCC announced the winning bidders for the RDOF Auction, and CCO Holdings was selected as a winning bidder for 8,406 Census Blocks in Missouri. Additionally, the FCC established a deadline of June 7, 2021 for submitting ETC designation documentation.

Based on this timing, the Charter Entities seek a waiver of the Commission's sixty-day pre-application notice rule set forth in 20 C.S.R. 4240-4.017 for good cause, as follows. 20 C.S.R. 4240-4.017(1)(D) permits an entity to request a waiver of the sixty-day pre-application notice rule and identifies several examples of good cause waiver requests, including: (i) the filing party had no communications with the office of the Commission about any substantive issues in their case within the 150-day period preceding their filing; (ii) circumstances prevented filing the required notice; and (iii) delaying a filing for sixty days would cause harm. In the case of this Joint Application, all of these reasons are appropriate. The Charter Entities were unable to discuss their ETC designation request with the Commission due to confidentiality restrictions under the FCC's RDOF Auction rules. The Charter Entities did not learn of their RDOF Auction winning bid in Missouri until December 7, 2020. And, lastly, compliance with the sixty-day pre-application notice rule would create substantial impediments, including a likelihood of significant harm, to the Charter Entities' ability to comply with the FCC's RDOF Auction procedures. Based upon the good cause showing above, the Commission should grant the Charter Entities' request for a waiver of the sixty-day pre-application notice requirement.

Second, as discussed, the timeframe for the Charter Entities to obtain ETC designation is short and, so that each Charter Entity may plan its RDOF construction and deployment schedule, the Charter Entities respectfully request that the Commission grant each of them ETC designation on an expedited basis by no later than April 15, 2021. Granting this Joint Application on an expedited basis will benefit the citizens of Missouri by allowing the Charter Entities to meet their RDOF deployment milestones for voice and broadband Internet services in the RDOF Census Blocks and by allowing customers the opportunity to reap the benefits of Charter’s broadband services, including by participating in telemedicine, remote work and remote education. Expedited Commission action would serve the public interest and advance the goals of universal service by expediting the deployment of high quality, innovative voice and broadband Internet services in these unserved portions of Missouri.

IV. THE CHARTER ENTITIES’ FINANCIAL AND TECHNICAL QUALIFICATIONS

Charter is one of the nation’s leading providers of broadband Internet access services and voice services, and Charter has played a significant role in expanding the availability of these services—especially broadband Internet access services—across the United States. Indeed, the Charter Entities and their affiliates currently provide high-quality voice and broadband services to approximately 26.8 million residential Internet access service customers and 9.3 million residential voice service customers in 41 states, including many in rural and “high cost” areas.

Each Charter Entity is highly qualified to meet the FCC’s RDOF service obligations given Charter’s proven track record of financial, managerial, technical and commercial success operating as an existing provider of broadband Internet and voice services. In 2019, Charter generated over \$45 billion in revenue from the provision of all of Charter’s services, along with approximately

\$6.5 billion in income from its operations.²⁶ The Charter Entities will draw upon Charter's financial capability and extensive teams of experienced engineers with expertise in the fields of communications technology, hardware design, software development, data analytics, and networking to construct and/or install the networks and infrastructure necessary to provide the required services in the RDOF Census Blocks. Additionally, the Charter Entities will leverage the significant operational, managerial and technical expertise of Charter to perform all billing, installation, customer service, and other matters related to providing their services in Missouri. The Charter corporate family has extensive experience managing the technical and customer service-related issues associated with the provision of mass-market consumer voice and broadband Internet access (as well as other communications services). Charter monitors its network performance on a 24/7/365 basis and has implemented procedures to leverage its extensive engineering resources quickly and effectively to install, modify, repair, and/or restore services, as necessary.

This expertise made it possible for CCO Holdings to confidently participate in the RDOF auction with the certainty that each Charter Entity will be able to fulfill its RDOF network and service obligations.

V. **EACH CHARTER ENTITY MEETS ALL FEDERAL AND STATE STATUTORY AND REGULATORY REQUIREMENTS FOR ETC DESIGNATION**

Each Charter Entity meets all applicable federal and state requirements for designation as an ETC in Missouri, including 47 U.S.C. § 214(e), 47 C.F.R. §§ 54.201 *et seq.*, and 20 C.S.R. 4240-31.015 and -31.016.

A. Each Charter Entity Meets All Federal Requirements for ETC Designation

Each Charter Entity meets all criteria for designation as an ETC under federal law, as follows.

1) For purposes of its ETC designation, each Charter Entity will operate as a common carrier and offer interstate and intrastate communications on a common carrier basis in its respective RDOF Census Blocks. Designation as an ETC is a predicate to each Charter Entity's eligibility to receive RDOF support to provide voice and broadband Internet services in its respective RDOF Census Blocks (47 U.S.C. § 214(e)(1); 47 C.F.R. § 9.3; 47 C.F.R. § 54.201(d)).

2) Charter is a facilities-based broadband Internet access and voice service provider, with its own network, gateways, switching facilities, and other associated facilities. Each Charter Entity will offer the RDOF supported services using its own facilities within the meaning of the FCC's rules or a combination of its own facilities and resale of another carrier's services (47 U.S.C. § 214(e)(1)(A); 47 C.F.R. § 54.201(d)(1)) within its respective RDOF Census Blocks.

3) As required by 47 C.F.R. § 54.101, each Charter Entity, either directly or through an affiliate, will offer voice services and broadband Internet access services supported by federal universal service support mechanisms, including the following capabilities within its respective RDOF Census Blocks:²⁷

Voice Grade Access to the Public Switched Telephone Network – Each Charter Entity meets this requirement through the provision of a competitive voice service that includes minutes of use for local service provided at no charge to end users and access to emergency services via

911 or E911, wherever available from local government or public safety organizations.²⁸ Toll limitation services will also be offered to qualifying low income consumers as provided in the FCC's rules (47 C.F.R. § 54.101(a)(1)) in the RDOF Census Blocks.

Broadband Internet Access Service – Charter's broadband Internet access service provides the capability to transmit data to, and receive data from, all or substantially all Internet endpoints, including any capabilities that are incidental to and enable the operation of the communications service (47 C.F.R. § 54.101(a)(2)) in the RDOF Census Blocks.

Each Charter Entity commits that these services will be provided consistent with applicable high-cost universal service support rules (47 C.F.R. § 54.101(c)) in the RDOF Census Blocks. Each Charter Entity will also ensure that Lifeline voice and broadband Internet services are offered in accordance with the FCC's rules in all Census Blocks where the Charter Entity has been assigned RDOF support (47 C.F.R. § 54.101(d)). Moreover, for its Lifeline voice service offering, each Charter Entity will offer to Lifeline-eligible customers a Charter voice service plan, as described above, at the discounted Lifeline voice service rate in the RDOF Census Blocks. This voice service plan is comparable (if not superior) to the Lifeline voice service offerings of other Lifeline providers in Missouri.

4) Each Charter Entity will offer its voice service as a standalone service and at rates that are reasonably comparable to urban rates (47 U.S.C. § 254(b)(3); 47 C.F.R. § 54.313(a)(3)) in its respective RDOF Census Blocks.²⁹

5) In its respective RDOF Census Blocks, each Charter Entity will advertise the availability of its universal service offerings and charges for such offerings using media of general

distribution (47 U.S.C. § 214(e)(1)(B); 47 C.F.R. § 54.201(d)(2)), and in a manner reasonably designed to reach those likely to qualify for the service (47 C.F.R. § 54.405(b)).

6) Each Charter Entity will provide the supported services throughout its designated RDOF Auction assigned Census Blocks where it has customers (47 U.S.C. § 214(e)(1); 47 C.F.R. § 54.201(d)).

7) Each Charter Entity certifies that, in accordance with 47 U.S.C. § 254(e) and 47 C.F.R. § 54.7(a), it will use federal universal service support only for the provision, maintenance, and upgrading of facilities and services for which the universal service support is intended.

8) Each Charter Entity further certifies that it meets all applicable requirements for designation as an ETC under 47 C.F.R. § 54.202 as follows:

Compliance with Applicable Service Requirements. Each Charter Entity certifies that it will comply with the service requirements applicable to the support that it receives,³⁰ including the requirements of the RDOF Auction.

Ability to Remain Functional in Emergency Situations. Charter has been providing voice and broadband Internet access services to customers on a 24/7/365 basis for almost twenty years. As part of providing these services, it is necessary to have in place contingency plans for emergency situations for each of Charter's major network hubs and/or facilities that are geographically distributed across the United States. These plans contain activation, staffing, escalation, and communication procedures to identify and respond to such emergencies. Additionally, all switching facilities are equipped with independent power generators and sufficient fuel to operate for several days to mitigate commercial power outages. The design of these facilities contains multiple levels of redundancy and autonomy that also mitigate the need

for dedicated human interaction. The Charter Entities will apply this successful model to their RDOF services in the RDOF Census Blocks.

B. Each Charter Entity Meets All State Requirements for ETC Designation

In addition to the foregoing, in accordance with the Commission's requirements for ETC designation under 20 C.S.R. 4240-31.016, each Charter Entity states as follows:

1) Each Charter Entity is owned 100% by its direct parent company. Each such parent company, in turn, is ultimately majority owned and wholly controlled by Charter, which is a publicly traded company.

2) The names and titles of the corporate officers of each Charter Entity are as follows:

John Bickham, President & COO
Christopher Winfrey, CFO
Richard Dykhouse, EVP, General Counsel & Corporate Secretary

3) The following companies share common ownership or management with each Charter Entity and both have received federal universal service funds as ETCs and participants in the federal Lifeline program:

Time Warner Cable Information Services (California), LLC
Time Warner Cable Information Services (New York), LLC

Time Warner Cable Information Services (California), LLC has also received state universal service funds in California. Other Charter affiliates have participated in the FCC's schools and libraries or rural healthcare programs under the federal Universal Service Fund.

4) The Charter Entities have numerous affiliates nationwide that are involved in the provision of cable video, voice and broadband Internet services, among others. Over the years, such affiliates have participated in inquiries, investigations and/or proceedings involving various federal or state regulatory or law enforcement agencies regarding different aspects of their

business. Due to the broad scope of the affiliates' operations, it is difficult or impractical to identify each relevant inquiry, investigation or proceeding, and/or to identify whether a concluded investigation resulted in a finding of liability particular to the enumerated list in 20 C.S.R. 4240-31.016(2)(B)(4). However, neither the Charter Entities nor the Charter family of companies knowingly engage in fraud, deceit, perjury, stealing, or the omission or misstatement of material facts in the course of their regular and ordinary business dealings and/or in connection with their everyday commercial transactions.

5) Information about each Charter Entities' voice services and rates in the RDOF Census Blocks may be obtained at: www.spectrum.com/home-phone or www.business.spectrum.com/phone. Information about Charter's broadband Internet access service offerings and rates in the RDOF Census Blocks may be obtained at: www.spectrum.com/Internet.

6) Each Charter Entity will comply with the Commission's ETC requirements identified in 4 C.S.R. 240-31.015 with respect to its provision of RDOF supported services in the RDOF Census Blocks.

7) The Charter Entities have been assigned RDOF funding as a result of the RDOF Auction. Any RDOF funding that the Charter Entities would receive as a result of the RDOF Auction would be provided from the Federal Universal Service Fund. For this reason, the Charter Entities are not applying in this Joint Application for support from the Missouri universal service fund, as described at 20 C.S.R. 4240-31.016. Each Charter Entity reserves its right to request such relief in the future if it is appropriate and in the public interest.

8) Each Charter Entity commits to notifying the Commission of any changes to its company contact information.

9) Each Charter Entity is certificated by the Commission to provide local exchange telecommunications services in Missouri. A copy of each Charter Entity’s certificate is attached at **Exhibits D and E**. Each Charter Entity is compliant with all applicable Commission reporting and assessment obligations.

10) Each Charter Entity is compliant with its contribution obligations to the federal universal service fund.

VI. DESIGNATION OF EACH CHARTER ENTITY AS AN ETC IS IN THE PUBLIC INTEREST

As a winning bidder in the RDOF Auction, each Charter Entity is eligible to receive funding to bring high-quality, innovative voice and broadband Internet access services to consumers in unserved portions of Missouri. The RDOF funding assigned to each Charter Entity will help enable it to “[b]ring digital opportunity to Americans living on the wrong side of the digital divide,”³¹ and thereby advance the goals of universal service. Expedited Commission action on this Joint Application serves the public interest by accelerating the deployment of high-quality, innovative voice and broadband Internet access services in unserved portions of Missouri that the Charter Entities and its affiliates will serve in the RDOF Census Blocks.

A. Broadband Deployment Will Promote New Investment, Job Growth and Opportunities in Missouri

Bringing broadband to unserved areas of Missouri has been a major priority of the Governor and state lawmakers. In a statement, Governor Mike Parson said of the importance of broadband, “Expanding broadband is essential to our state’s infrastructure ... Connecting more Missourians with high-speed internet will allow them to utilize digital platforms for education,

health, and business”³² Granting this Joint Application will serve the state’s goal of expanding its infrastructure and the public interest through the deployment of broadband Internet and voice services to unserved high-cost areas in Missouri. Deployment of those services will spur investment in facilities and equipment and promote new economic opportunities and job growth in Missouri.

Designating the Charter Entities as ETCs will permit them to receive RDOF Auction funds for 8,406 Census Blocks in Missouri, directly advancing the goals of the RDOF Auction and universal service in those RDOF Census Blocks. Moreover, the more than \$1.2 billion of RDOF funding assigned to Charter, which includes more than \$48 million in Missouri, will help enable it to expand the availability of Charter’s network and services throughout Charter’s service areas, including in Missouri, as discussed in **Exhibit H**. Missouri State Senator Mike Cierpiot said of the importance to close the digital divide, “If we’re ever going to get rural areas caught up economically, [broadband] is kind of a basic thing to have . . . If we could just get the funding for it, there’s a real chance it would help the problem.”³³ Charter’s deployments will bring expanded voice and broadband connectivity to these areas, many of which are rural and less densely populated in Missouri, which will help close the digital divide for residents of the state and expand economic opportunity and job growth in communities that will benefit from increased connectivity. Because granting this Joint Application will allow each Charter Entity to use its respective RDOF funds as intended to expand voice and broadband Internet access services in its

respective RDOF Census Blocks in Missouri, designating each Charter Entity as an ETC is in the public interest.

B. Access to Broadband Will Transform Rural and Unserved Areas

The availability of Charter's RDOF supported broadband Internet access services and voice services will have a transformative effect on the unserved and/or rural areas in the RDOF Census Blocks. Charter is committed to expanding access to this life-changing connectivity that will enable consumers to use new technologies, such as distance education, telemedicine, live streaming video, or interactive programming (e.g., a Zoom call). These technologies will create new opportunities for consumers in education, healthcare, business, and civic engagement activities. For example, with access to an online network made available through a Charter broadband Internet connection, an individual may start their own business or take online classes in pursuit of an education. Similarly, local businesses, through use of Charter's broadband Internet and voice services, may connect to vendors and employees, grow their sales, and create new jobs. In short, Charter's broadband Internet access and voice services will enhance the opportunities available to the consumers served by each Charter Entity in its respective RDOF Census Blocks.

C. The Public Will Benefit from Charter's Experience as a Lifeline Voice Service Provider

Charter and its subsidiaries have substantial experience in providing Lifeline voice services to low income consumers and communities, which provides the Charter Entities with important familiarity with the FCC's Lifeline program and with the interactions necessary with the Universal Service Administrative Company, the National Lifeline Accountability Database, and other third party Lifeline administrators. These experiences will facilitate each Charter Entity's swift offering of Lifeline voice services for qualifying low-income customers in the Census Blocks where such Charter Entity receives RDOF support in Missouri.

D. The Public Will Benefit from Charter's Customer-Oriented Policies, Such as Those During The COVID-19 Pandemic

At the onset of the COVID-19 pandemic, Charter joined other telecommunications providers in the Keep Americans Connected Pledge. As part of that effort, Charter voluntarily committed to suspend collections and not charge late fees or terminate service for residential or small business customers who informed Charter that they were experiencing COVID-related economic challenges. Charter extended its commitment through June 30th. During that time, Charter kept connected approximately 700,000 customers who had difficulties meeting bills because of COVID-related economic hardship. Charter has also forgiven approximately \$85 million in customer overdue balances.

Additionally, as schools across the country began to transition to remote learning in March, Charter took action to benefit students, faculty and families. Charter committed to offering broadband Internet service up to 200 Mbps for free for sixty days, including in-home Wi-Fi and a self-installation kit, to households with K-12 and/or college students or educators who did not already have a Charter broadband Internet service subscription for sixty days. Charter extended this offer through June 30th and, by the end of the 2020 school year, Charter was able to help nearly 450,000 students and teachers nationally continue schooling through remote learning. To help ease the strain for families and teachers who still lacked broadband, Charter relaunched its Remote Education Offer beginning on September 21, 2020.

Furthermore, for schools and school districts seeking to establish a centralized purchasing arrangement for the benefit of both students and teachers to support remote learning, Charter currently offers Stay Connected K-12 throughout the Charter footprint. Under Stay Connected K-12, Charter contracts directly with schools and school districts to assist them in offering high-speed broadband Internet access to students, educators and staff in their homes. Charter's Stay

Connected K-12 is designed as a single-payer option for communities to allow payment by a school or school district, based upon the number of connections purchased. This partnership between Charter and the school or school district helps to ensure that learning, teaching, and working are uninterrupted by giving schools and school districts the flexibility to add students to the program, when needed, and to provide much needed in-home broadband Internet connectivity.

Lastly, recognizing the importance of digital skills during this time of unprecedented volume in distance learning and remote working, Charter has doubled the amount of funds available for its Spectrum Digital Education Grants for 2020-21.³⁴ These customer-oriented policies, along with others that Charter implements from time to time, will enhance the choices and capabilities available to the consumers served by each Charter Entity and its affiliates in its respective RDOF Census Blocks.

E. The Public Will Benefit from Each Charter Entity’s Advanced Service Offerings

Designating each Charter Entity as an ETC in its respective RDOF Census Blocks will promote the deployment of advanced voice and broadband Internet services in these areas. Charter is widely recognized as a premier provider of voice and broadband Internet offerings that relies on advanced systems, technologies, and infrastructure. Charter provides voice and broadband Internet services to approximately 26.8 million residential Internet access service customers and 9.3 million residential voice service customers in 41 states. Its investments have enabled it to offer minimum download speeds of at least 200 Mbps in 60% of Charter’s national footprint, and 100 Mbps everywhere else in the footprint—including households and small businesses in rural areas. On December 17, 2020, Charter announced that it plans to double Charter’s broadband Internet

access service starting speeds in 17 U.S. markets, including the areas in and around Columbia, Missouri, making 200 Mbps the starting flagship speed in 75% of Charter’s communities. These speed enhancements will be available to new customers immediately. Existing customers will receive these speed increases with new Charter broadband Internet access service packages during the first quarter of 2021.³⁵

Charter also offers a 1 Gbps connection with maximum download speeds of up to 940 Mbps to the vast majority of those same households, as well as to small and medium-sized businesses. Charter’s broadband Internet service offerings enable customers “to use tomorrow’s Internet applications as well as today’s.”³⁶ These levels of service will be made available to consumers in each Charter Entity’s RDOF Census Blocks, as well.





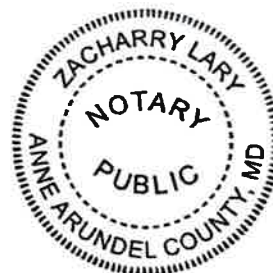

MISSOURI: ASSIGNED RDOF CENSUS BLOCKS

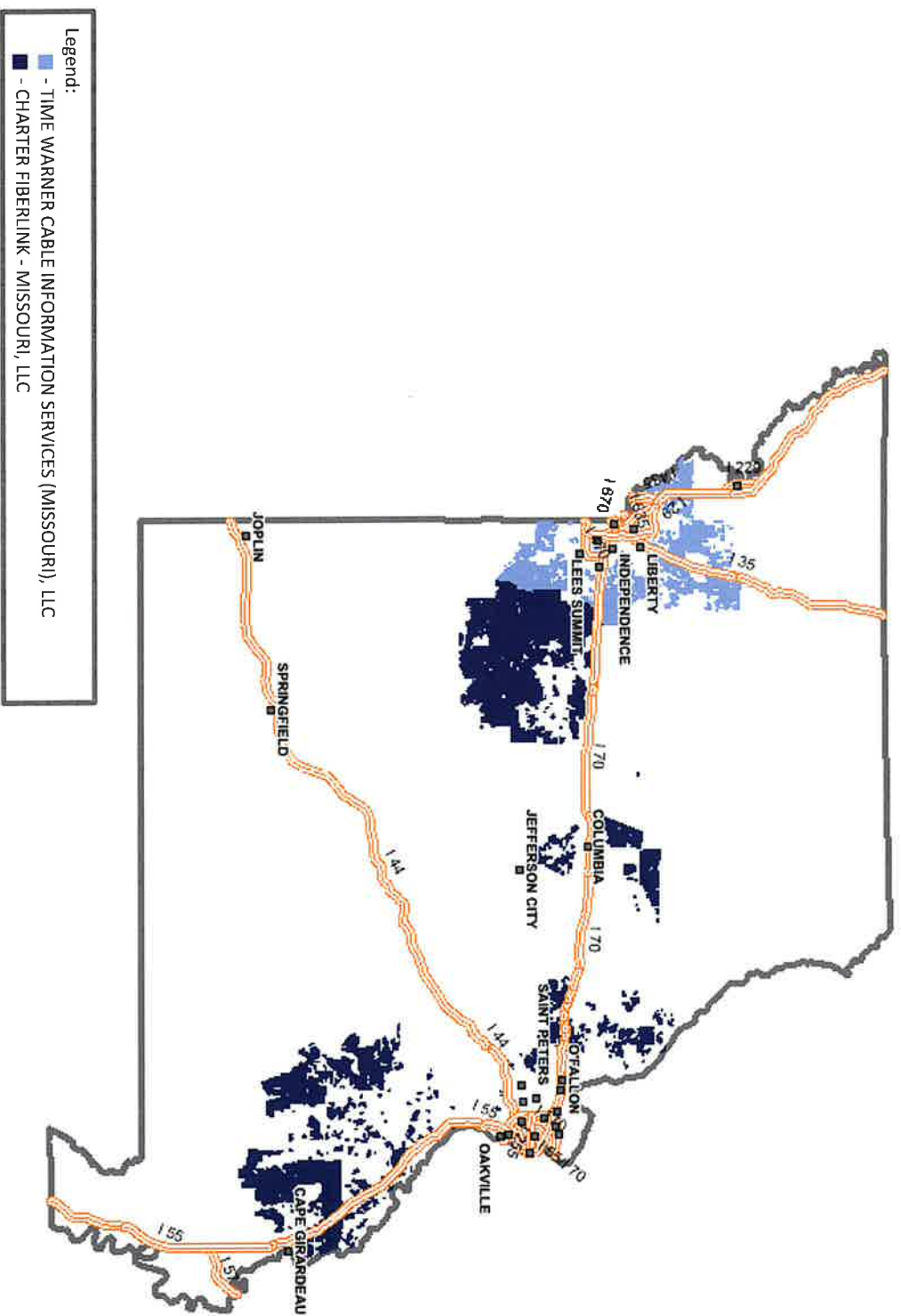

ORDER GRANTING CERTIFICATE TO PROVIDE BASIC LOCAL AND INTEREXCHANGE TELECOMMUNICATIONS SERVICES

Procedural History

Charter Fiberlink - Missouri, LLC (Charter), applied to the Missouri Public Service Commission on December 4, 2000, for a certificate of service authority to provide basic local and interexchange telecommunications services in Missouri under Sections 392.410 - .450, RSMo 2000.¹ Charter asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420.

The Commission issued a notice and schedule of applicants on December 12, 2000, directing interested parties wishing to intervene to do so by December 27, 2000, for interexchange, and January 11, 2001, for basic local service authority. There were no applications to intervene. On January 29, 2001, Charter filed its First Amended Application. Charter filed a Motion to Supplement First Amended Application on March 9, 2001. The Staff of the Commission (Staff) filed a Staff Recommendation on March 19, 2001.

¹ All statutory references are to Revised Statutes of Missouri 2000 unless otherwise indicated.

Findings of Fact

The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has requested a hearing in this case, the Commission may grant the relief requested based on the verified application. The Missouri Public Service Commission, having considered all of the competent and substantial evidence upon the whole record, makes the following findings of fact:

Charter is wholly owned by Charter Fiberlink, LLC, and is an affiliate of Charter Communications, Inc. Charter is a Delaware corporation with principal offices located at 12444 Powerscourt Drive, Suite 100, St. Louis, Missouri 63131. Commission Rule 4 CSR 240-2.060 requires a corporation applying for certification to provide telecommunications services to include in its application a certificate from the Secretary of State showing that it is authorized to do business in Missouri, a description of the types of service it intends to provide, a description of the exchanges where it will offer service, and a proposed tariff with a 45-day effective date. Charter has provided the required documentation except for the proposed tariff. Charter requested a temporary waiver of 4 CSR 240-2.060(6)(C)² until it has entered into an interconnection agreement with the underlying local exchange carrier and that agreement has been approved by the Commission. Charter stated that it will submit to the Commission for approval a proposed tariff

bearing no less than a 30-day effective date in a manner consistent with recent Commission practice in similar cases.

Exhibit B to the application lists the names and qualifications of Charter's management team. In addition to academic credentials, the team members have experience in various areas of the telecommunications industry. Staff stated that in its opinion Charter possesses sufficient technical and managerial experience to provide basic local exchange telecommunications service.

Charter submitted as Exhibit D to its application the necessary financial information. In addition, Staff stated that in its opinion Charter passes the minimum standard to provide basic local exchange telecommunications service.

The Commission finds that Charter possesses sufficient technical, financial and managerial resources and abilities to provide basic local telecommunications service.

Charter stated in its application that it will provide services that will meet the minimum basic local service standards required by the Commission, including quality of service and billing standards. In its recommendation, the Staff concurs with this allegation. The Commission finds that Charter proposes to offer basic local services that satisfy the minimum standards established by the Commission.

Charter is seeking certification to provide basic local exchange telecommunications services in portions of Missouri that are currently served by Southwestern Bell Telephone Company, Sprint/United Telephone Company, and GTE Midwest Incorporated.³ Charter indicates that the specific exchanges within which it proposes to offer service are listed in the incumbent providers' respective local exchange tariffs. Charter is not

³ Now doing business as Verizon Midwest.

asking for certification in any area that is served by a small incumbent local exchange carrier (ILEC). Staff stated in its recommendation that in its opinion, Charter has sufficiently identified the geographic area in which it proposes to offer basic local service and that the area follows ILEC exchange boundaries and is no smaller than an exchange. The Commission finds that Charter has sufficiently identified the geographic area in which it proposes to offer service and that Charter has demonstrated that the area follows ILEC exchange boundaries and is no smaller than an exchange.

Charter states that all the services it proposes to offer will be subject to sufficient competition to justify a lesser degree of regulation. Charter is proposing to offer all forms of basic local exchange and interexchange telecommunications service. Charter intends to provide basic local exchange and interexchange telecommunications service as a facility-based provider and on a resale basis.

Charter stated that it will offer basic local telecommunications service as a separate and distinct service and that, in compliance with section 392.455(5), it will provide equitable access, as determined by the Commission, for all Missourians within the geographic area in which it will offer basic local services. In its recommendation, Staff concurs with this statement. Therefore, the Commission finds that Charter will provide basic local exchange service as a separate and distinct service and that Charter has committed to provide equitable access.

Charter states that considerations of the public interest and particularly equitable access for potential subscribers to service who reside in the area sought to be certified, warrant the granting of this application in that Charter will extend the benefits of competition into the intrastate interexchange market, increase the diversity of choice, and

shall increase consumer access to competitive and affordable telecommunications services.

Staff recommends that Charter be classified as a competitive telecommunications carrier. Staff also recommends that Charter's certificate be conditioned upon certain limitations on its ability to charge for its access services and that Charter's certificate become effective when its tariff becomes effective. Staff's recommended conditions are as follows:

- A. If Charter provides access service, its originating and terminating access rates will be no greater than the lowest Commission approved corresponding access rates in effect for each ILEC within whose service area Charter seeks authority to provide service, unless authorized by the Commission pursuant to Sections 392.220 and 392.230, RSMo.
- B. The service authority and service classification for switched exchange access is granted conditioned on the continued applicability of Section 392.200, RSMo, and the requirement that any increases in switched access service rates above the maximum switched access service rates set forth herein shall be made pursuant to Sections 392.220 and 392.230, RSMo, and not Sections 392.500 and 392.510, RSMo.
- C. If the directly competing ILEC, in whose service area Charter is operating, decreases its originating and/or terminating access service rates, Charter shall file an appropriate tariff amendment to reduce its originating and/or terminating access rates in the directly competing ILEC's service area within 30 days of the directly competing ILEC's reduction of its originating and/or terminating access rates in order to maintain the cap.

The Commission finds that all the telecommunications services Charter proposes to offer are subject to sufficient competition to justify a lesser degree of regulation. Therefore, the Commission finds that all of Charter's proposed telecommunications services are competitive telecommunications services.

Conclusions of Law

Certificate of Service Authority

The Commission has the authority to grant certificates of service authority to provide telecommunications service within the state of Missouri. Charter has requested certification under Sections 392.410 - 392.450, which permit the Commission to grant a certificate of service authority where it is in the public interest. The federal Telecommunications Act of 1996 and Section 392.455, were designed to institute competition in the basic local exchange telecommunications market in order to benefit all telecommunications consumers. See Section 392.185.

Section 392.455, RSMo 2000, sets out the requirements for granting certificates to provide basic local telecommunications service to new entrants. A new entrant must: (1) possess sufficient technical, financial and managerial resources and abilities to provide basic local telecommunications service; (2) demonstrate that the services it proposes to offer satisfy the minimum standards established by the Commission; (3) set forth the geographic area in which it proposes to offer service and demonstrate that such area follows exchange boundaries of the ILEC and is no smaller than an exchange; and (4) offer basic local telecommunications service as a separate and distinct service. In addition, the Commission must give due consideration to equitable access for all Missourians to affordable telecommunications services, regardless of where they live or their income.

The Commission finds that Charter meets the statutory requirements for provision of basic local telecommunications services and has stated it will abide by those requirements in the future. The Commission determines that granting Charter a certificate of service authority to provide basic local exchange telecommunications services is in the public interest.

Competitive Classification

Charter requested that its basic local services be classified as competitive and that the application of certain statutes and regulatory rules be waived. The Commission may classify a telecommunications provider as a competitive company if the Commission determines it is subject to sufficient competition to justify a lesser degree of regulation. Section 392.361.2. In making that determination, the Commission may consider such factors as market share, financial resources and name recognition, among others. *In the Matter of the Investigation for the Purpose of Determining the Classification of the Services Provided by Interexchange Telecommunications Companies Within the State of Missouri*, 30 Mo. P.S.C. (N.S.) 16 (1989); *In the Matter of Southwestern Bell Telephone Company's Application for Classification of Certain Services as Transitionally Competitive*, 1 Mo. P.S.C. 3d 479, 484 (1992). In addition, the Commission may classify a telecommunications company as a competitive telecommunications company only upon a finding that all telecommunications services offered by such company are competitive telecommunications services pursuant to Section 392.361.3. The Commission has found that whether a service is competitive is a subject for case-by-case examination and that different criteria may be given greater weight depending upon the service being considered. *Id.* at 487.

The Commission finds that competition in the basic local exchange telecommunications market is in the public interest. The Commission has found that all the telecommunications services offered by Charter are competitive telecommunications services and that the telecommunication services Charter proposes to offer are subject to sufficient competition to justify a lesser degree of regulation. Therefore, the Commission concludes that Charter should be classified as a competitive company.

Waivers and Conditions

Subsection 392.470.1 authorizes the Commission to impose conditions upon a telecommunications service provider which the Commission deems reasonable and necessary and which are in the public interest and consistent with the purposes of Chapter 392. Sections 392.361 and .420 authorize the Commission to modify or suspend the application of its rules and certain statutory provisions for companies classified as competitive or transitionally competitive.

The Commission finds that Charter has met the requirements of 4 CSR 240-2.060 for applicants for certificates of service authority to provide telecommunications services with the exception of the filing of a tariff with an effective date which is no fewer than 45 days after the tariff's issue date. The Commission finds that Charter has demonstrated good cause to support a temporary waiver of the tariff filing requirement and the waiver should be granted.

In addition to the waiver of the tariff requirement, Charter requested a waiver of the following statutes: Sections 392.210.2, 392.240(1), 392.270, 392.280, 392.290, 392.300.2, 392.310, 392.320, 392.330, RSMo Supp. 1999, and 392.340. Charter also requested that the application of these Commission rules be waived: 4 CSR 240-10.020; 4 CSR 240-30.010(2)(C), 4 CSR 240-30.040, 4 CSR 240-32.030(4)(C), 4 CSR 240-33.030, and 4 CSR 240-35. Staff notes that this particular rule pertains to the filing of exchange boundary maps and is not applicable to the provision of interexchange telecommunications services. Therefore, Staff recommended that application of this rule not be waived for the provision of interexchange telecommunications services. However, Staff does recommend that this provision be waived as to the provision of basic local exchange telecommunications service.

The Commission has found that the telecommunication services Charter proposes to offer are subject to sufficient competition to justify a lesser degree of regulation. The Commission has also found that Charter is a competitive company. Therefore, the Commission determines that Charter should be granted the same waivers of the statutes and rules as the Commission usually grants to competitive companies. The waivers are set out in the ordered paragraph below.

The Commission also finds that the conditions that the staff recommends are reasonable and necessary to protect the public interest and that they further the purposes of Chapter 392 as stated in Section 392.185. Therefore, the Commission finds that Charter's competitive classification and certification should be expressly conditioned as recommended by staff and as ordered below.

IT IS THEREFORE ORDERED:

1. That Charter Fiberlink - Missouri, LLC, is granted a certificate of service authority to provide basic local telecommunications services in the state of Missouri, subject to the conditions of certification set out below and to all applicable statutes and Commission rules except as specified in this order.

2. That Charter Fiberlink - Missouri, LLC, is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.

3. That Charter Fiberlink - Missouri, LLC, is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived for the provision of basic local telecommunications services:

 392.240.1 - rates-rentals-service & physical connections
 392.270 - valuation of property (ratemaking)
 392.280 - depreciation accounts

 392.340 - reorganization(s)
 392.330 - issuance of securities, debts and notes



ORDER GRANTING CERTIFICATE TO PROVIDE

MOTION TO AMEND APPLICATION

This order grants a certificate of service authority to provide basic local, local exchange and interexchange telecommunications services in the state of Missouri, classifies those services and the company as competitive, waives certain statutes and regulations and grants Applicant's motion to amend its application.

Procedural History and Background

On September 12, 2003, Time Warner Cable Information Services (Missouri), LLC, filed an Application for a Certificate of Service Authority to provide local and interexchange voice telecommunications services within the state of Missouri, and for competitive classification. On September 23, 2003, the Missouri Public Service Commission issued its Notice of Applications for Intrastate Certificates of Service Authority and Opportunity to Intervene, establishing October 8 as the deadline for intervention with regard to interexchange services and October 23, as the deadline for intervention with regard to local exchange. Because Time Warner sought to provide services involving aspects of Voice

over Internet Protocol, applications to intervene were filed by a number a parties wishing to be included in a general discussion of the subject. On November 4, 2003, the Commission granted the applications and set the matter for prehearing conference. Prior to the prehearing conference additional applications to intervene were filed out of time and granted by the Commission. As a result of the prehearing conference, the parties and the Commission realized that the services Time Warner sought to provide did not merit a broad discussion of Voice over Internet Protocol. In light of this realization, the Commission established a separate case, Case No. TW-2004-0324, for the purpose of investigating issues surrounding Voice over Internet Protocol.

Also, as a result of the prehearing conference, some intervenors opposed the application filed by Time Warner because Time Warner did not request certification to provide basic local service. Those parties objected because if Time Warner were granted an application to provide local exchange and interexchange voice services, and not basic local, the Company would not be subject to the same regulatory restrictions as companies who have been granted certificates to provide basic local service.

On February 13, 2004, Time Warner filed a Motion to amend its application to include a request to provide basic local service. Also, on February 13, Time Warner filed a Stipulation and Agreement showing that the parties either support or do not oppose the motion to amend the application.

On February 23, 2004, the Staff of the Missouri Public Service Commission filed its Memorandum. Staff recommends that Time Warner be granted a certificate to provide basic local, local exchange and interexchange voice services. Staff also recommends that that competitive classification and waivers granted to Time Warner.

Discussion

Time Warner's seeks certification to provide basic local, local exchange, and interexchange voice services in portions of Missouri that are currently being served by Southwestern Bell Telephone Company, Sprint Missouri, Inc., and CenturyTel

The Commission may grant an application for a certificate of service authority to provide basic local telecommunications service upon a showing that: (1) the applicant has met the statutory requirements,¹ and (2) the grant of authority is in the public interest.² The applicant must also comply with the Commission's procedural rules.³

Time Warner is also requesting that it and its services be classified as competitive and that the application of certain statutes and regulatory rules be waived. The Commission may classify a telecommunications service as competitive if the Commission determines that the applicant is subject to a sufficient degree of competition to justify a lesser degree of regulation.⁴ The Commission may only classify a telecommunications carrier as competitive if all of its services are so classified.⁵ The Commission may waive the application of certain statutes and of its rules to a competitive carrier if it determines that such waiver is consistent with the purposes of Chapter 392.⁶

Findings of Fact

The Missouri Public Service Commission, having considered all of the competent and substantial evidence upon the whole record, makes the following findings of fact. The positions and arguments of all of the parties have been considered by the Commission in making this decision. Failure to specifically address a piece of evidence, position or argument of any party does not indicate that the Commission had failed to consider relevant evidence, but indicates rather that the omitted material was not dispositive of this decision.

Requirements of the Commission's Rules:

Commission Rules 4 CSR 240-2.060(1) and (6) require that an entity seeking certification to provide basic local telecommunications services provide certain information to the Commission in its application, including: a description of the business organization of the applicant, supported by the certificate of the Missouri Secretary of State; names and addresses for contact purposes; a disclosure of any pending or final judgments or decisions against it from any state or federal agency or court involving customer service or rates; a verified statement that there are no outstanding annual reports or assessment fees owed to this Commission; if applicable, a request to be classified as a competitive telecommunications company; a description of the types of service the applicant intends to provide; the exchanges in which service is to be offered; and, a proposed tariff with an effective date which is not fewer than 45 days after its issue date.

Having reviewed the application and supporting materials filed by Time Warner, the Commission finds that Time Warner has complied with each of these requirements except for the proposed tariff. Time Warner requests a temporary waiver of 4 CSR

240-2.060(6)(1)(C)⁷ until it has entered into interconnection agreements and such agreements have been approved by the Commission. Time Warner agrees to file tariffs after interconnection agreements have been obtained and will not provide service prior to any such tariffs being effective.

Requirements of Section 392.450:

Section 392.450.1 provides that the Commission may grant a basic local certificate only upon a finding, after notice and a hearing, that the applicant has complied with the certification process established under Section 392.455. Thus, an applicant's satisfaction of the requirements of the Commission's regulations and of Section 392.455 also satisfies Section 392.450.1. As explained below, the Commission does find that Time Warner has satisfied the requirements of the Commission's regulations and of Section 392.455, and consequently finds that Time Warner has complied with the certification process established by the Commission in satisfaction of Section 392.450.1.

Section 392.450.2 provides that an applicant for a basic local certificate must (1) file and maintain tariffs with the Commission in the same manner as the incumbent local exchange carriers and (2) meet the minimum service standards, including quality of service and billing standards, that the Commission requires of the competing incumbent local exchange carriers.

Time Warner did not file a proposed tariff in support of its application. However, Time Warner stated it will comply with all applicable Commission rules except those

expressly waived by the Commission. Thus, Time Warner has agreed to provide services that will meet the minimum basic local service standards required by the Commission, including quality of service and billing standards. Staff recommends that the certificate be granted. Having reviewed Time Warner's application and supporting materials, as well as Staff's Memorandum and Recommendation, the Commission finds that Time Warner has met the requirements of Section 392.450.2.

Requirement of Section 392.455:

Section 392.455 authorizes the Commission to establish a process to grant basic local certification to new entrants and to grant certificates to new entrants to provide basic local telecommunications service on a common carriage basis. That section further requires that a new entrant: (1) possess sufficient technical, financial and managerial resources and abilities to provide basic local telecommunications service; (2) demonstrate that the services it proposes to offer satisfy the minimum standards established by the Commission; (3) set forth the geographic area in which it proposes to offer service and demonstrate that such area follows the exchange boundaries of the incumbent local exchange telecommunications company and is no smaller than an exchange; and, (4) offer basic local telecommunications service as a separate and distinct service. Finally, Section 392.455 also requires that the Commission give due consideration to equitable access for all Missourians to affordable telecommunications services, regardless of where they live or their income.

In support of its application, Time Warner submitted, as Exhibit C to its application, the names and qualifications of its key personnel. As Exhibit E to its application, Time Warner submitted Form 10-K, An Annual Report Pursuant to Section 13 or 15(d) of the

Securities Exchange Act of 1934 for the fiscal year ending December 31, 2002. Time Warner also submitted a letter, Exhibit F, "from Time Warner Entertainment Company, L.P., demonstrating its commitment to provide the necessary financial support to the operation of [Applicant]." In its Memorandum, Staff indicated that Time Warner has sufficient technical, financial and managerial resources and recommends that the application be granted.

Having reviewed Time Warner's application and supporting materials, as well as Staff's Recommendation and Memorandum, the Commission finds that Time Warner has met the requirements of Section 392.455(1) in that it has shown that it possesses sufficient technical, financial and managerial resources and abilities to provide basic local telecommunications service.

As previously noted, Time Warner has stated that it will comply with all applicable Commission rules except those expressly waived by the Commission. Based on this statement, the Commission finds that Time Warner has demonstrated that the services it proposes to offer satisfy the minimum standards promulgated in Section 392.455(2).

In its Application, Time Warner seeks certification in the exchanges or service areas of the incumbent local exchange companies of Southwestern Bell Telephone Company, Sprint Missouri, Inc., and CenturyTel. Staff agrees that Time Warner has sufficiently identified the exchanges in which it seeks certification and recommends that the application be approved. Having reviewed Time Warner's Application and supporting material, as well as Staff's Memorandum and Recommendation, the Commission finds that Time Warner has met the requirements of Section 392.455(3) in that it has set forth the geographic area in which it proposes to offer service and has demonstrated that such area follows the

exchange boundaries of the incumbent local exchange telecommunications companies and is no smaller than an exchange.

In its Application, Time Warner states that it will offer basic service as a separate and distinct service. Based on this statement, the Commission finds that Time Warner has met the requirements of Section 392.455(4), that all providers offer basic local telecommunications service as a separate and distinct service.

In its Application, Time Warner states that it will give consideration to equitable access for all Missourians, regardless of where they reside or their income, to affordable telecommunications service. Section 392.455(5) requires the Commission give due consideration in this regard. Time Warner's statement furthers this requirement.

Requirement for Competitive Classification

If the requested certification is granted, Time Warner will compete with an incumbent local exchange carrier in each exchange in which it provides basic local telecommunications service. The Commission finds that Time Warner will thus be subject to a sufficient level of competition to justify a lesser degree of regulation. Furthermore, all of the services Time Warner will offer are thus qualified for classification as competitive services.

Conclusions of Law

The Missouri Public Service Commission has reached the following conclusions of law:

Jurisdiction:

The Commission is authorized to create a process by which to certify new entrants to provide local exchange telecommunications services in Missouri as common carriers, and is further authorized to grant such certificates, after notice and a hearing, where it is in

the public interest.⁸ The Commission is also authorized to classify services and companies as competitive or transitionally competitive and waive certain statutory provisions and Commission rules.⁹ The Commission may also impose any reasonable and necessary conditions upon telecommunications service providers if such conditions are in the public interest and consistent with the provisions and purposes of this chapter.¹⁰

The Public Interest:

Having found that Time Warner has met all of the requirements for certification to provide basic local telecommunications service as a common carrier, it remains to be determined whether it is in the public interest to grant the requested certificate. It has been legislated¹¹ that “[t]he provisions of this chapter shall be construed to . . . promote diversity in the supply of telecommunications services and products throughout the state of Missouri; [and to] . . . [a]llow full and fair competition to function as a substitute for regulation when consistent with the protection of ratepayers and otherwise consistent with the public interest[.]” In consideration of the foregoing, and based upon its finding that Time Warner has met all of the requirements for the requested certification, the Commission concludes that granting the requested certification is in the public interest. The Commission also finds that competition in the interexchange telecommunications market is in the public interest and Time Warner should be granted a certificate of service authority to provide interexchange telecommunications services.

Competitive Classification:

Time Warner seeks competitive classification and the Commission has found that Time Warner will be subject to competition to justify a lesser degree of regulation. The Commission has further found that all of Time Warner's services will be entitled to classification as competitive services. Therefore, the Commission may classify Time Warner as a competitive telecommunications company if such lesser degree of regulation is consistent with the protection of ratepayers and promotes the public interest. In consideration of these findings and of the public interest, the Commission concludes that granting competitive classification to Time Warner is consistent with the protection of ratepayers and promotes the public interest.

Waivers:

The Commission may waive certain statutes and administrative rules for competitively classified carriers "if such waiver or modification is otherwise consistent with the other provisions of Section 392.361 to 392.520 and the purposes of this chapter."¹² The Commission has developed a standard list of statutes and regulations that it waives for competitive local exchange and interexchange carriers. The Commission will waive these provisions for Time Warner because to do so furthers the purposes of Chapter 392 to foster and encourage the development of competition in the telecommunications industry.

Staff's recommendation indicates that Time Warner should be classified as a competitive telecommunications company. Staff agrees that Time Warner's switched exchange access services may be classified as a competitive service, conditioned upon

certain limitations on Time Warner's ability to charge for its access services. Those limitations are as follows:

1. Time Warner's originating and terminating access rates will be no greater than the lowest Commission approved corresponding access rates in effect for each ILEC within whose service area Western seeks authority to provide service, unless authorized by the Commission pursuant to Sections 392.220 and 392.230.
2. The Certificate and service classification for switched access services is conditioned on the continued applicability of Section 392.200, and the requirement that any increase in switched access services rates above the maximum switched access service rates set forth herein shall be made pursuant to Sections 392.220 and 392.230, and not Sections 392.500 and 392.510.
3. If the directly competing ILEC, in whose service area the applicant is operating, decreases its originating and/or terminating access service rates, the applicant shall file an appropriate tariff amendment to reduce its originating and/or terminating access rates in the directly competing ILEC's service area within 30 days of the directly competing ILEC's reduction of its originating and/or terminating access rates in order to maintain the cap.

The Commission has considered the conditions proposed by Staff and concludes that they are reasonably necessary to protect the public interest and should be adopted.

Also, the Commission has considered Time Warner's application to amend its application and, finding that it is reasonable, will grant the motion.

Time Warner is advised that the grant of authority contained in this order may not, by itself, be sufficient to permit Western to lawfully provide telecommunications services in Missouri.

IT IS THEREFORE ORDERED:

1. That Time Warner Cable Information Services (Missouri), LLC, is granted a certificate of service authority to provide basic local telecommunications services in the exchanges of Southwestern Bell Telephone Company, Sprint Missouri, Inc., and

CenturyTel, subject to the conditions and recommendations contained in the Staff's Memorandum.

2. That Time Warner Cable Information Services (Missouri), LLC, is granted a certificate to provide non-switched local exchange telecommunications service restricted to dedicated private line services.

3. That Time Warner Cable Information Services (Missouri), LLC, is granted a certificate to provide interexchange telecommunications services.

4. That Time Warner Cable Information Services (Missouri), LLC, is granted competitive classification.

5. That Time Warner Cable Information Services (Missouri), LLC's, certification and competitive status are expressly conditioned upon the continued applicability of Section 392.200, RSMo 2000, and on the requirement that any increase in switched access service rates above the maximum switched access services rates set forth in the agreement must be cost justified pursuant to Section 392.220, RSMo 2000, and 392.230, rather than Section 392.500 and 392.510.

6. That Time Warner Cable Information Services (Missouri), LLC's, originating and terminating access rates will be no greater than the lowest Commission-approved corresponding access rates in effect for each incumbent local exchange carrier within whose service area Western Communications, Inc., seeks authority to provide service, unless authorized by the Commission pursuant to Section 392.220 and 392.230, RSMo 2000.

7. That the certificate and competitive service classification for switched exchange access is granted conditioned on the continued applicability of Section 392.200,

RSMo 2000, and the requirement that any increase in switched access service rates above the maximum switched access service rates set forth herein shall be made pursuant to Section 392.200 and 392.230, RSMo 2000, and not Section 392.500 and 392.510, RSMo 2000.

8. That if the directly competing incumbent local exchange carrier, in whose service area Time Warner Cable Information Services (Missouri), LLC, is operating, decreases its originating or terminating access service rates, Time Warner shall file an appropriate tariff amendment to reduce its originating or terminating access rates in the directly competing incumbent local exchange carrier's service area within 30 days of the directly competing incumbent local exchange carrier's reduction of its originating or terminating access rates in order to maintain the cap.

9. That Time Warner Cable Information Services (Missouri), LLC, will provide essential services, as required by Section 392.451, RSMo 2000, and delineated at 4 CSR 240-31.010(5).

10. That application of the following statutes and Commission rules are waived:

- 392.290 - issuance of securities

- 392.340 - reorganization(s)
- 392.330 - issuance of securities, debts and notes

Commission Rules

- 4 CSR 240-10.020 - depreciation fund income

- 4 CSR 240-30.040 - uniform system of accounts
- 4 CSR 240-32.030(4)(C) - exchange boundary maps
- 4 CSR 240-33.030 - minimum charges

11. That Rule 4 CSR 240-3.510(1)(C) is waived. Time Warner Cable Information Services (Missouri), LLC, may not operate until its tariffs have been submitted to the Commission and approved.

12. That Time Warner Cable Information Services (Missouri), LLC, is advised that the grant of authority contained in this order may not, by itself, be sufficient to permit Western Communications, Inc., to lawfully provide telecommunications services in Missouri.

13. That Time Warner Cable Information Services (Missouri), LLC's motion to amend its application is granted.

14. That this order and Time Warner Cable Information Services (Missouri), LLC's certificate shall become effective on March 12, 2004.
