# ORDER ALLOWING TIME TO FILE AMENDED REPORT AND GRANTING REQUEST TO MAKE MOTION PUBLIC

The Empire District Electric Company filed its 2017 Reliability Compliance Report on June 29, 2018, as it is required to do by Commission Rule 4 CSR 240-23.020(3). The Office of the Public Counsel responded to that report on July 10, raising concerns about aspects of the report. Because Empire filed its Report as entirely confidential, Public Counsel had to file much of its motion as confidential as well. The Commission directed Empire to respond to Public Counsel's concerns by July 25.

In its response, filed on July 25, Empire asked that it be allowed until August 1 to file an amended report. Empire's response also indicated nothing in Public Counsel's July 10 response needs to be treated as confidential. Public Counsel filed a motion on July 26, asking that its July 10 response be reclassified as public.

#### THE COMMISSION ORDERS THAT:

- The Empire District Electric Company shall file an amended 2017 Reliability Compliance Report by August 1, 2018.
- Public Counsel's July 10, 2018 Motion to Open File for Comments or in the
   Alternative Accept Late Filed Comments shall be reclassified as public.
