The Commission directed its Staff (Staff) file a pleading stating Staff’s interest in filing a recommendation concerning Evergy Missouri Metro and Evergy Missouri West’s (collectively “Evergy”) Program Year 2020 Evaluation Measurement & Verification Final Report (PY2020 EM&V Report). Staff states it did not, and does not plan to, file a change report. However, Staff asks the Commission to direct Evergy to meet with stakeholders at least once to discuss outstanding issues with the PY2020 EM&V Report.

THE COMMISSION ORDERS THAT:

1. Evergy shall schedule a meeting, to take place prior to October 31, 2021, to address outstanding issues with the PY2020 EM&V Report with interested stakeholders.
2. This order is effective when issued.
