**ORDER DIRECTING THE FILING OF
PROPOSED PROCEDURAL SCHEDULE**

On July 22, 2022, the Commission’s Staff (Staff) filed *Staff’s Change Request*, asking the Commission to make changes to Evergy Missouri Metro and Evergy Missouri West’s (collectively “Evergy”) Program Year 2 Evaluation, Measurement, and Verification (EM&V) Report. Evergy filed a response opposing Staff’s proposed changes. According to Evergy’s EM&V plan (filed as an attachment to its November 29, 2018, MEEIA Cycle 3 2019-2022 filing) stakeholders were to hold a conference within five days of the change request deadline and agree to a procedural schedule with an evidentiary hearing to resolve the change request. Therefore, the Commission will direct the parties to file a proposed procedural schedule.

THE COMMISSION ORDERS THAT:

1. The parties shall file a joint proposed procedural schedule no later than August 25, 2022.
2. This order shall be effective when issued.
