Re: Name Change Request from Aquila, Inc. dba Aquila Networks – L&P and Aquila, Inc. dba Aquila Networks – MPS, to Aquila, Inc. dba KCP&L Greater Missouri Operations Company

Dear Ms. Dale:

Effective upon the closing of the transactions authorized by the Missouri Public Service Commission ("Commission") Report and Order dated July 1, 2008, in Case No. EM-2007-0374, which is tentatively set for July 14, 2008, a wholly-owned subsidiary of Great Plains Energy Incorporated ("Great Plains Energy"), a Missouri corporation, will be merged with and into Aquila, Inc. ("Aquila"), a Delaware corporation. Aquila will be the surviving corporation.

Once the merger is consummated, Aquila, Inc. dba Aquila Networks – L&P and Aquila, Inc. dba Aquila Networks – MPS (collectively, "Aquila Networks") intends to begin doing business as KCP&L Greater Missouri Operations Company, subject to approval of the requested name change by the Commission. To that end, we hereby seek authorization pursuant to 4 CSR 240-2.060(5) to change the names of both Aquila, Inc. dba Aquila Networks – L&P and Aquila, Inc. dba Aquila Networks – MPS, to Aquila, Inc. dba KCP&L Greater Missouri Operations Company. There are no changes to the rates, terms or conditions of the tariffs, but merely the required adoption notice and revised tariff title sheet for each respective entity.

As required by 4 CSR 240-2.060(5), we hereby provide as follows:

- (A) The old names to be changed are (i) Aquila, Inc. dba Aquila Networks L&P and (ii) Aquila, Inc. dba Aquila Networks MPS. The new name for both entities will be Aquila, Inc. dba KCP&L Greater Missouri Operations Company.
- (B) Evidence of registration of the new fictitious name with the Missouri secretary of state will be filed as soon as possible as a late-filed exhibit, but prior to the granting of the authority sought herein (4 CSR 240-2.060(2)).
- (C) In accordance with 4 CSR 240-2.060(5)(C), enclosed please find adoption notices and revised tariff title sheets, with effective dates that are not fewer than thirty (30) days after the filing date of this application, for the Missouri-jurisdictional steam and electric businesses of Aquila Networks. While the tariff sheets bear an issued date of July 2, 2008, and an effective date of August 1, 2008, by a separately filed motion for expedited treatment, we will be requesting that the tariff sheets become effective July 14, 2008, to conform to the anticipated closing date of the above-referenced transactions.
