ORDER SETTING TIME FOR RESPONSES AND DIRECTING STAFF RECOMMENDATION

On June 11, 2021, Union Electric Company d/b/a Ameren Missouri's contracted, independent, third-party evaluator, Opinion Dynamics, filed its plan year 2020 ("PY20") evaluation, measurement, and verification ("EM&V") schedule EM&V Report. On June 24, 2021, in accordance with Commission Rule 20 CSR 4240-20.093(8), the Commission's independent auditor, Evergreen Economics, submitted its audit of the PY20 evaluations. As a result of Evergreen Economics' review, Staff filed a change request on July 1, 2021.

On July 2, 2021, Ameren Missouri filed an *Application for Modification of Demand Side Management Plan, and Approval of Associated Variances* seeking approval of the modification of its Demand-Side Management Portfolio and Plan for years 2019-21 ("MEEIA-2019-21 Plan") in order to extend the plan's effective date through December 31, 2023. The company also asks for the approval of variances from certain Commission rules for the requested extension. Ameren Missouri filed supporting information and testimony with its application.

The Commission will set a time for responses to Staff's change request and Ameren Missouri's application. Additionally, the Commission will direct Staff to file a recommendation regarding Ameren Missouri's application.

THE COMMISSION ORDERS THAT:

1. No later than July 15, 2021, the Staff of the Commission shall file either a recommendation regarding Ameren Missouri's application or a status report indicating when it will be able to file a recommendation.
2. Any other responses to Ameren Missouri's application or the Staff's change request shall be filed no later than July 15, 2021.
3. This order is effective when issued.
