On June 30, 2023, The City of Kansas City (Kansas City) filed an application to intervene in this matter. The Commission granted limited intervention to Kansas City on July 6, 2022, because the time for objections to Kansas City's application had not passed. On July 5, 2023, Google LLC filed an application to intervene. More than ten days have elapsed and no party has objected to either application to intervene.¹ The applications satisfy the requirements of Commission Rule 20 CSR 4240-2.075, and are in the public interest. Intervention will be granted.

THE COMMISSION ORDERS THAT:

1. Kansas City's application to intervene is granted.
2. Google LLC's application to intervene is granted.

¹ Commission rule 20 CSR 4240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.
