ORDER GRANTING EXTENSION

On February 9, 2023, Union Electric Company d/b/a Ameren Missouri and Callaway Electric Cooperative ("Cooperative")(collectively, "Joint Applicants"), jointly filed an application seeking Commission approval of an amendment to an existing territorial agreement. The Joint Applicants have requested expedited treatment such that the Commission would issue a decision within 60 days, which would be by April 10, 2023. The Commission directed the Staff of the Commission (Staff) to file a recommendation with regard to the application or a request for an extension of time to do so.

Staff timely requested an extension of time to file its recommendation until May 5, 2023. Staff stated it needed additional time to complete its analysis. Staff's request also noted the property in question is currently receiving service. By Commission rule, ten days are allowed for parties to respond to any pleading.¹ No objections or responses were received.

The Commission finds the unopposed request reasonable and will grant it.
