ORDER AUTHORIZING TRANSFER OF ASSETS

Issue Date: September 4, 2012 Effective Date: September 14, 2012

Background

On July 10, 2012, Union Electric Company d/b/a Ameren Missouri filed an application to sell a portion of its system to Hunter Engineering Company. For aesthetic reasons, Hunter, which receives service from Ameren Missouri, decided to replace aerial facilities with underground facilities at its own expense. However, if Hunter were to do this, Ameren Missouri would be unable to provide service to the light fixtures illuminating Hunter's parking lot. To solve this problem, Hunter offered to purchase the fixtures and related equipment from Ameren Missouri. Ameren Missouri has agreed to sell the fixtures and related equipment to Hunter for \$2,210.91. This amount represents the total installed reproduction cost of the facilities less accumulated depreciation.

Staff Recommendation

On August 20, the Staff of the Commission filed its recommendation to approve the application. Based on the application and responses to data requests, Staff states that

Ameren Missouri's request meets the filing requirements and is not detrimental to the public interest. In its Memorandum, Staff informs the Commission that the specific items to be sold are: five 35-foot tall light fixtures, 380 feet of 600-volt cable and two luminaire, metal halide, 120-volt flood lights. Staff points out that because the transaction would reduce Ameren Missouri's overall rate base in the amount of the sale price, which Staff quotes as \$2,211.00, Ameren Missouri customers would benefit.

Discussion

Section 393.190.1 RSMo requires Ameren Missouri to seek Commission approval prior to transferring any property necessary and useful in the performance of its duties. Through this application, Ameren Missouri is complying with Missouri law. Further, the Commission may not deny this transfer unless it is shown that the transfer is detrimental to the public interest. No party has suggested that the sale of assets is detrimental to the public interest.

Commission rules 4 CSR 240-2.060 and 3.110 require Ameren Missouri to supply certain information to the Commission, which the company has done. Upon review of the verified pleadings, the Commission concludes that Ameren has complied with the filing requirements for a transfer of assets and that the proposed transfer is not detrimental to the public interest. Having so concluded, the Commission will approve the application.

THE COMMISSION ORDERS THAT:

The application to transfer assets from Union Electric Company d/b/a Ameren
 Missouri to Hunter Engineering Company is approved.
