NOTICE

Comes now, Terry M. Jarrett, Commissioner for the Missouri Public Service Commission, and for this Notice in the above captioned matter states the following;

- (1) On September 3, 2009, I made a presentation to the Missouri Energy Development Association ("MEDA")¹ in St. Louis, Missouri. My presentation titled "Regulation in an Uncertain World" related to matters of general regulatory policy and did not address the merits or the specific facts, evidence, claims, or positions presented or taken in a pending case. Additionally, my presentation did not address any issue which is the subject of a case that has been filed with the commission, and the presentation also did not address substantive or procedural matters that are the subject of a pending filing or case.
 - (2) To my knowledge, MEDA is not now a party to the above captioned case.
- (3) 4 CSR 240-4.020(8) addresses *ex parte* communications, and the steps which are necessary when a Commissioner *receives* a communication. Here, I *gave* a speech.
- (4) The Missouri Legislature has provided that Commissioners shall not have any imposition or limitation on the free exchange of ideas, views, and information provided that they

Additionally, on August 21, 2009 this same presentation was presented to the Missouri Industrial Energy Consumers ("MIEC"), and subsequently made available on the Commission's website for public review, where it has and continues to be available to the general public, including interested persons and parties to this case. Further, as was done at the MIEC presentation, I took no questions from the audience, my presentation was transcribed by a court reporter and the transcript was made publicly available through the Commission's website. A transcript of my presentation to MEDA will be posted to the Commission's website when it becomes available.
