On May 28, 2013, Kansas City Power & Light Company ("KCP&L") filed its 2013 Annual Renewable Energy Standard Compliance Plan and Report pursuant to Commission Rule 4 CSR 240-20.100. On the same date, it also filed a Revised 2012 Plan and Report ("Plans and Reports").

KCP&L filed these Plans and Reports in File No. EE-2013-0452. That file was opened to rule upon KCP&L's Application for Variance from a Commission rule requiring KCP&L to file its Plan and Report by April 15. The Commission will close File No. EE-2013-0452 as it has already granted KCP&L the variance. The Commission opens File No. EO-2013-0504 to receive the Plans and Reports.

The Commission will direct notice and establish a deadline for Staff to file a report and for other interested entities to file comments.

THE COMMISSION ORDERS THAT:

1. File No. EE-2013-0452 is closed.
2. The Commission's Data Center shall provide notice of this order upon each party to File Number EO-2012-0348 and ER-2012-0174.

3. The Commission's Data Center shall serve a copy of this order upon the county commission of each county within Kansas City Power & Light Company's service area.


4. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing Kansas City Power & Light Company's service area and to the news media serving Kansas City Power & Light Company's service area.

5. The Staff of the Missouri Public Service Commission shall examine Kansas City Power & Light Company's Annual Renewable Energy Standard Compliance Plans and file a report of its review no later than July 12, 2013.

6. No later than July 12, 2013, the Office of the Public Counsel, and any other interested person or entity, may file comments regarding Kansas City Power & Light Company's Annual Renewable Energy Standard Compliance Plans.

7. This order shall become effective upon issuance.
