JOINT MOTION TO AMEND PROCEDURAL SCHEDULE

COMES NOW, the Staff of the Missouri Public Service Commission, by and through counsel, and hereby files this Motion To Amend Procedural Schedule on behalf of Staff, Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company (collectively "the Companies") and the Office of the Public Counsel ("OPC") (collectively "the Parties").

1. The Parties have met on three occasions, most recently April 11, 2014, to discuss/address the Companies' Application for approval of its Cost Allocation Manual (CAM) filed on December 16, 2013. After July 2, 2014	Response Time to Data Requests is 10 calendar days to respond, 5 calendar days to object, and 5 calendar days to notify of the need for additional time to respond.
July 14-16, 2014	Settlement Conference in Jefferson City.
July 22, 2014	List of Issues, Order of Witnesses, Order of Cross-Examination, etc.
July 24, 2014	Statement of Positions
August 6-7, 2014	Evidentiary Hearing

2. The Parties do not believe that any changes are necessary in the procedures that the Parties previously recommended to the Commission and that the Commission ordered in its Order Setting Procedural Schedule, issued February 6, 2014.
