**PROPOSED COMPROMISE PROCEDURAL SCHEDULE**

**COMES NOW** Staff of the Missouri Public Service Commission, by and through undersigned counsel, and hereby files its *Proposed Compromise Procedural Schedule* in response to the Commission’s February 3<sup>rd</sup> Order Directing Filing in response to the proposed procedural schedule filed by Ameren Missouri in its December 22, 2014 application for approval of certain demand-side programs, a Technical Resource Manual (TRM), and a Demand-Side Investment Mechanism (DSIM) as contemplated by the Missouri Energy Efficiency Investment Act (MEEIA) (hereafter referred to as “MEEIA Cycle 2”). In support thereof, Staff states:

1. Due to the press of workload related to three electric general rate cases and Staff requirements to complete its Ameren Missouri Chapter 22 comments and report and Ameren Missouri’s Fuel Adjustment Clause (FAC) prudence report, the Staff has proposed a compromise procedural schedule for this case and has circulated it for review of the parties. Accordingly the Staff proposes the following key procedural schedule dates for progressing Ameren Missouri’s MEEIA Cycle 2 filing:

- Rebuttal Testimony - March 20, 2015
- Surrebuttal Testimony- April 13, 2015
- List Issues, Order of Witnesses/Cross April 21, 2015

- Evidentiary Hearing- May 11-13, 2015
- Initial Briefs - May 28, 2015
- Reply Briefs - June 4, 2015
- Expected Order - June 24, 2015

2. Staff counsel has discussed this proposed schedule with counsel for Ameren Missouri and Office of Public Counsel and has circulated it to counsel for other parties and is not aware of any objection to the above proposed schedule dates.

**WHEREFORE**, Staff respectfully requests the Commission accept its *Proposed Compromise Procedural Schedule* as set forth above.
