STAFF RECOMMENDATION TO APPROVE TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and for its *Staff Recommendation to Approve Tariff Sheets* respectfully states:

1. On November 20, 2020, Union Electric Company d/b/a Ameren Missouri ("Ameren") filed revised tariff sheets to remove language associated with energy efficiency programs that were applicable for the period 2016-2018.
2. The tariff sheets contained a proposed effective date of December 20, 2020, and were assigned Tariff Tracking No. YE-2021-0121.
3. By its *Order Directing Staff to File a Recommendation and Setting Time for Responses* issued November 23, 2020, the Commission ordered Staff to file a recommendation regarding these tariff sheets no later than December 2, 2020.
