## JOINT MOTION FOR EXTENSION OF TIME TO FILE A LIST OF ISSUES AND STATEMENT OF POSITIONS

COME NOW the Staff of the Missouri Public Service Commission ("Staff"), KCP&L Greater Missouri Operations Company (GMO), Missouri Department of Natural Resources (MDNR), the Office of the Public Counsel (OPC), Missouri Industrial Energy Consumers (MIEC), Sierra Club, Natural Resources Defense Council (NRDC), Renew Missouri, Sam's East, Inc. ("Sam's Club"), Wal-Mart Stores, Inc. ("Wal-Mart"), known collectively herein as "the Parties"<sup>1</sup>, and files this *Motion For Extension Of Time To File a List of Issues, and Statement Of Positions (Motion)* with the Missouri Public Service Commission (Commission) and states as follows:

- 1. On April 11, 2012, the Commission issued an *Order Granting Motion to Modify Procedural Schedule*, by which the Commission ordered that the List of Issues be filed no later than May 11, 2012 and the Statements of Position be filed no later than May 16, 2012.
- 2. Due to the Parties continued settlement discussions, involvement in several MEEIA cases, at least three anticipated depositions in another MEEIA filing next week, and the necessary leave of the Staff's main witness, the Staff asks for additional

time to work with the Parties. Staff has submitted a draft issue list to the Parties for their review and comment.

3. The Parties anticipate filing a Joint List of Issues, Order of Witnesses and Order of Cross Examination no later than May 31, 2012, and Statements of Positions no later than June 6, 2012. If the Parties cannot reach an agreement, the Parties will file separate lists for the Commission's consideration.

**WHEREFORE**, the Staff files this *Motion* requesting the Commission extend the dates by which the Parties are to file a joint List of Issues and Position Statements, to the dates suggested by the Parties in this *Motion*.
