**APPLICATION FOR THE CANCELLATION OF CERTIFICATE OF SERVICE  
AUTHORITY AND WITHDRAWAL OF TARIFF**

COMES NOW Zayo Fiber Solutions, LLC (the "Company"), pursuant to Section 392.410.5 RSMo and the Rules of the Missouri Public Service Commission ("Commission"), and hereby requests the Commission to cancel its Certificate of Service Authority ("CSA") as well as any approved tariff. In support of its request, the Company states the following:

1. Zayo Fiber Solutions, LLC is a Delaware limited liability company and a wholly-owned subsidiary of Zayo Group, LLC ("Zayo"). A copy of the Company's Certificate of Authority to Transact Business is provided as Exhibit A. A copy of the Company's Certificate of Good Standing from the Missouri Secretary of State is provided hereto as Exhibit B.

4. The Company's principal offices are currently located at 400 Centennial Parkway, Suite 200, Louisville, CO 80027.

5. In Missouri, the Company is authorized to provide non-switched local exchange and interexchange telecommunications services pursuant to the Certificate of Service Authority ("CSA") granted by the Commission in Case No. CA-2008-0306 on April 30, 2008 as amended File No. XN-2011-0026 on October 7, 2010 (to reflect new name).

6. The Company has never provided telecommunications services in Missouri and due to a proposed intra-corporate *pro forma* merger with Zayo, with Zayo surviving the merger, the Company has no intention of doing so in the future. The Company, therefore, no longer requires its CSA.

7. Because the Company does not serve any customers or have any active operations in Missouri, the Company respectfully submits that the cancellation and surrender of its CSA and withdrawal of its tariff are reasonable and necessary.

8. The Company states that, to the best of its knowledge, (1) there are no annual reports or assessment fees that are overdue for the Company in Missouri and (2) the Company does not have any pending action or unsatisfied final judgments or decisions against it in any state, federal agency, or court which involves customers service or rates, which has occurred within three years of this Application.

9. The Commission has the authority to cancel a CSA pursuant to Section 392.410.5 RSMo (Supp 2009), which provides that:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if after proper notice and opportunity to intervene, no party requests such a hearing.

WHEREFORE, the Company respectfully requests that the Commission grant this Application and cancel the Certificate of Service Authority of Zayo Fiber Solutions, LLC and withdraw its approved tariff on file, together with such other and further relief as is necessary or convenient to affording the relief herein requested.
