## ORDER SETTING TIME FOR RESPONSES

Effective Date: February 2, 2022

On November 22, 2021, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) submitted an application requesting authority to encumber assets in connection with issuances of mortgage bonds in one or more series from time to time.

EMW also sought expedited treatment of its financing application, requesting Commission approval no later than February 14, 2022, so that it may access the capital markets on or about March 1, 2022. In addition, EMW requested waiver of the Commission's 60-day notice requirement.

On January 25, 2022, in lieu of a recommendation from the Staff of the Commission (Staff), Staff and EMW filed a nonunanimous *Stipulation and Agreement*. On February 1, 2022, the Office of the Public Counsel (OPC) filed an *Objection to Stipulation and Agreement* (Objection).

In recognition of EMW's request for expedited treatment of its application, the Commission will shorten the time allowed to respond to OPC's Objection<sup>1</sup>.

1. Responses to OPC's Objection shall be filed no later than 10:00 a.m., February 7, 2022.
2. This order shall be effective when issued.
