The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. 1. Quality Voice & Data, Inc. is registered to provide IVoIP services in the exchanges set forth in the affidavit attached to the application and restated above.

2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on June 30, 2023.
4. This file shall be closed on July 1, 2023.
