ORDER CANCELING REGISTRATION

Issue Date: June 30, 2016

Effective Date: July 10, 2016

On June 13, 2016, Staff filed a motion requesting the Commission cancel Reflective Group's registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the State of Missouri. The Commission granted Reflective Group its IVoIP registration in the State of Missouri in File No. DA-2014-0248.

Staff states in its motion that on June 9, 2016, the company notified the Commission that it no longer wished to be registered as an IVoIP provider in Missouri.

On June 15, 2016, the Commission issued an Order Establishing Time to Respond allowing parties to file an objection or request a hearing no later than June 27. No objections or requests for a hearing were filed.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Reflective Group's request and Staff's motion, the Commission finds that the IVoIP registration granted to Reflective Group, shall be canceled.

1. The registration to provide Interconnected Voice over Internet Protocol services granted to Reflective Group, in File Number DA-2014-0248, is canceled.
2. This order shall become effective on July 10, 2016.
3. This case may be closed on July 11, 2016.

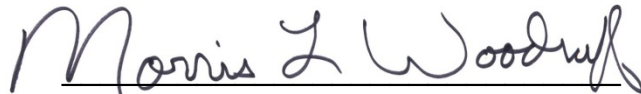
