REPORT FILING


COMES NOW Missouri Gas Energy (MGE), a division of Southern Union Company,
and states the following to the Missouri Public Service Commission (Commission):

1. In Case No. GR-2006-0422, the Missouri Public Service Commission approved funding in the amount of \$705,000 for a water heater rebate program. MGE previously filed tariffs in Case No GT-2008-0005 to effectuate this order of the Commission.
2. Those tariffs, among other things, required MGE, within fifteen months of the start of the program to file a report with the Commission assessing the overall cost effectiveness and the effectiveness of the program delivery process of the first twelve months of MGE's residential natural gas conservation initiatives along with recommendations for improving the programs.
3. MGE was initially required to file the described report with the Commission by November 15, 2008. In Commission Case No. GE-2009-0194, MGE requested, and was granted a variance from Sheet No. 100 such that MGE was allowed to file the evaluation report by February 15, 2009.
4. The report has since been completed and forwarded to the members of the Energy Efficiency Collaborative for comment. Attached hereto for filing as **Appendix A** (Program Evaluation for Missouri Gas Energy's Water Heater Program) is MGE's report assessing the overall cost effectiveness and the effectiveness of the program delivery process of the first

twelve months of MGE's water heater rebate program and recommendations for improving the program.

WHEREFORE, MGE respectfully requests that the Commission consider the filing of the attached report to comply with MGE's tariffs.
