ORDER DIRECTING NOTICE AND SETTING DATE FOR INTERVENTION

This order provides notice of the application filed by Aquila, Inc., to construct an electric distribution substation in Clay County, Missouri. The order also sets a period for the filing of intervention requests.

On December 28, 2006, Aquila filed an application with the Missouri Public Service Commission pursuant to Section 393.170, RSMo 2000, requesting that the Commission grant it a certificate of convenience and necessity to construct, own, operate, and maintain an electric distribution substation in Clay County, Missouri. Aquila stated that no other utility's facilities will be crossed by the proposed electric station. The Commission finds it appropriate that notice of this application be made to the general public and interested parties and that a date for intervention of proper parties be set.

The Data Center of the Commission shall provide notice of this application to the county commission of Clay County and to each of the parties to Aquila's current rate case. In addition, the Commission's Public Information Office shall make notice of this order available to the media serving Company's service area and to the members of the General Assembly representing the residents of the Company's service area.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party or governmental entity is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary and that the Applicant may submit its evidence in support of the Application by verified statement. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. P.S.C.*, 776 S.W.2d 494, 496 (Mo. App. 1989).

- The Data Center of the Missouri Public Service Commission is ordered to serve notice on the county commission of Clay County and the parties to Case No. ER-2007-0004.
- 2. The Information Officer of the Missouri Public Service Commission is ordered to make notice available to the media serving Company's service area and to the members of the General Assembly representing the residents of the Company's service area.
