ORDER DIRECTING FILING

The Missouri Public Service Commission is directing Kansas City Power & Light Company (“KCP&L”) to file a version of the *Supplemental Filing of Transource Missouri, LLC, Kansas City Power & Light Company, and KCP&L Greater Missouri Operations Company (“Supplemental Filing”)*¹ that will reflect the disclosure of the information as described in the *Submission of Asset Purchase Agreement*.²

Transource Missouri, LLC; KCP&L; and KCP&L Greater Missouri Operations Company filed the *Supplemental Filing* in a complete confidential version, and in a redacted public version, as the Commission’s regulations provide.³ KCP&L filed the *Submission of Asset Purchase Agreement*, which states that some of the *Supplemental Filing’s* highly confidential information is no longer confidential:

[T]he control budget estimates that were provided in Paragraph 2 as “highly confidential” figures are no longer confidential. Southwest Power Pool, Inc. (“SPP”) issued its “First Quarterly Project Tracking Report 2014” on January 7, 2014, which contains estimates related to the Sibley-Nebraska City Project, as well as other projects. The

base estimate of the project continues to be \$404,000,000. When the project's AFUDC (allowance for funds used during construction) of \$3,764,364 is added to the base estimate, the first quarter 2014 cost estimate, as reported by SPP, is \$407,764,364. See Exhibit C. [4]

Redaction is authorized for information that is confidential but not otherwise.

Therefore, the Commission will order KCP&L to file a public version of the *Supplemental Filing* without the redaction of information that is no longer highly confidential, as described above.

THE COMMISSION ORDERS THAT:

1. The filing described in the body of this order is due on January 31, 2014.
2. This order shall become effective immediately upon issuance.
