On May 4, 2022, the Commission issued its *Report and Order*, which became effective June 3, 2022, regarding the Ninth Prudence Review of the Fuel Adjustment Clause (FAC) of Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) and the Third Prudence Review of the FAC of Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro)(collectively, "Evergy").
