On June 9, 2021,¹ the Commission issued its Report and Order Approving Third Addendum to Territorial Agreement. On June 23, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy”) issued its Compliance Tariff Revision, Tracking Number YE-2021-0256, with an effective date of July 23, 2021, and on that date the Commission ordered the Commission Staff (Staff) to file a recommendation and other parties to file responses no later than July 9. On July 9, Evergy issued a Substitute Compliance Tariff; and the Commission extended the deadline for Staff’s recommendation and other parties’ responses to July 19 at 10:00 a.m. On July 19, the Staff filed its recommendation that the Commission approve the tariff as substituted on July 14. The Commission has received no other responses to the tariff filing. Based on Staff’s recommendation, the Commission will take no action

regarding Evergy's Compliance Tariff Revision YE-2021-0256, and it will go into effect on July 23, 2021.
