## MOTION FOR EXTENSION

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff") and for its *Motion for Extension* respectfully states:

- 1. On April 15, 2021, Evergy Metro, Inc. d/b/a Evergy Missouri Metro ("Evergy Metro") filed its 2020 Renewable Energy Standard (RES) Compliance Report ("Report"), as required by Commission Rule 20 CSR 4240-20.100(8).
- 2. The next day, April 16, 2021, the Commission issued its *Order Directing Notice of Filing*, ordering Staff to review Evergy's Report, and file its own report detailing Staff's findings within forty-five days, per Commission Rule 20 CSR 4240-20.100(8)(D). The Commission ordered Staff to file its report no later than June 1, 2021.<sup>1</sup>
- 3. Staff has two data requests awaiting responses due by June 3 and June 15, 2021, respectively. Staff has also indicated a number of corrections that needed to Evergy Metro's current Report.
- 4. In order to give Evergy Metro time to respond to Staff's data requests and to discuss the necessary corrections, and give Staff the necessary time to analyze and incorporate the responses into its report, Staff respectfully requests an extension through June 22, 2021 per Commission Rule 20 CSR 4240-2.050(3)(A).
