ORDER DIRECTING NOTICE AND SETTING DEADLINES FOR INTERVENTION APPLICATIONS AND STAFF'S RECOMMENDATION

On July 1, 2021, Evergy Missouri West Inc., d/b/a Evergy Missouri West (Evergy West) filed a revised tariff sheet proposing a revised fuel adjustment rate and bearing an effective date of September 1, 2021. Also on July 1, 2021, Evergy West initiated a rate adjustment mechanism true-up, to be included in the proposed fuel adjustment rate. Commission Rule 20 CSR 4240-20.090 provides a 60-day timeline for resolution of these rate adjustment mechanism proceedings. The Commission will direct notice be given and set a deadline for intervention applications. The Commission will also direct Staff to file recommendations in both cases, as required by 20 CSR 4240-20.090. Parties to Evergy West's most recent general rate proceeding in which the Commission established, continued or modified the electric utility's rate adjustment mechanism are automatically

parties to these proceedings without application for intervention, pursuant to 20 CSR 4240-20.090(17). Thus, the parties to File No. ER-2018-0146 are parties to these cases.

THE COMMISSION ORDERS THAT:

- 1. The Commission's data center shall add the parties to File No. ER-2018-0146 to the service list for these cases, and shall provide a copy of this order to those parties.
- 2. The Commission's data center shall provide notice of this order to the county commissions for each county in Evergy West's service territory.
- 3. The Commission's Public Policy and Outreach Department shall provide notice of this order to news media serving residents in Evergy West's service territory and members of the General Assembly representing residents in Evergy West's service territory.
- 4. Applications for intervention shall be filed no later than August 2, 2021. Any such filing shall be submitted through the Commission's electronic filing and information system or delivered to: Secretary Missouri Public Service Commission P. O. Box 360 Jefferson City, MO 65102.
- 5. No later than August 2, 2021, the Commission's Staff shall file recommendations reporting Staff's examination and analysis of Evergy West's application and tariff sheet in these two cases.
 - 6. This order shall be effective when issued.
