MOTION FOR LEAVE TO FILE AMENDED DOCUMENTS



1. Ameren Missouri filed its Application herein on September 30, 2011.
2. Ameren Missouri seeks leave to file two amended documents related to that Application. The first document is the attached Amended Verification. The verification filed with the Application inadvertently omitted the signer’s title. The amended verification includes the signer’s title. The second amended document is the attached Amended Appendix C, which is a map of the proposed service area. The Amended Appendix C is drawn to the scale of ½ inch = 1 mile. The original Appendix C was drawn to a different scale.
3. No party should be prejudiced by the proposed amendments, as no procedural schedule has been set in this matter and no substantive change has been made to the Application.
