ORDER DIRECTING FILING

On August 15, 2019,¹ the Commission issued its *Order Rejecting Fuel Adjustment Clause Tariff, Scheduling a Procedural Conference and Directing the Filing of a Revised Tariff* ("August 15 Order"). This order required KCP&L Greater Missouri Operations Company ("GMO") to file tariff sheets to implement interim fuel adjustment rates to reflect the parts of its proposed adjustment not in dispute. On August 21, GMO filed Tariff Revision YE-2020-0033 with an effective date of September 1. The interim tariff removed all disputed amounts. On August 26, the Commission issued its *Order Approving Interim Tariff*.

The August 15 Order set a procedural conference on September 5 and ordered a proposed procedural schedule no later than September 12. On September 12, GMO filed a *Response to Order Directing Filing*. GMO's response states GMO will not seek recovery of the amount removed by GMO from the fuel adjustment rate associated with Sibley fuel transfer in accumulation period 24 or any other accumulation period in its Fuel

Adjustment Clause. GMO states the issues related to auxiliary power in this proceeding have been tried in Case No. ER-2019-0067 and so do not need to be tried here. GMO states that there is, accordingly, no need for a procedural schedule in these files and that the Commission Staff and the Office of Public Counsel concur.

The Commission will suspend its order requiring a proposed procedural schedule and order the Commission Staff to file a recommendation. This recommendation should address the status of interim Tariff No. YE-2020-0033 and the disposition of these files.

THE COMMISSION ORDERS THAT:

1. The Commission's August 15, 2019, order requiring a proposed procedural schedule no later than September 12, 2019, is suspended.
2. The Commission Staff shall file a recommendation on the status of interim Tariff No. YE-2020-0033 and the disposition of the above-captioned files no later than September 23, 2019.
3. This Order shall be effective when issued.
