ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DATE, AND DIRECTING FILING OF STAFF RECOMMENDATION

On December 2, 2019, Evergy Metro, Inc., d/b/a Evergy Missouri Metro (formerly known as Kansas City Power & Light Company), filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism Rider. The tariff sheets bear an effective date of February 1, 2020. Commission rule 20 CSR 4240-20.093(4) requires the Commission's Staff to examine and analyze the information Evergy Missouri Metro has filed and to submit a recommendation no later than 30 days after Evergy Missouri Metro filed its tariff revision. The Commission has sixty days to act on Evergy Missouri Metro's filing.

Commission rule 20 CSR 4240-20.093(15)(A) provides that the parties to Evergy Missouri Metro's previous case where a demand-side program was approved "shall have the right to be a party to any subsequent related periodic rate adjustment proceeding without the necessity of applying to the [C]ommission for intervention; however, such person or entity shall file a notice of intention to participate within the intervention period." Thus, the parties to Evergy Missouri Metro's File No. EO-2015-0240 may become parties

to this proceeding by filing a notice as set out below. The Commission will also establish a deadline for the filing of applications to intervene and direct its Data Center to serve a copy of this order upon the county commission of each county in Evergy Missouri Metro's electric service area. In addition, the Commission's Public Information Office shall make notice of this order available to the media serving Evergy Missouri Metro's electric service area and to the members of the Missouri General Assembly representing the residents of Evergy Missouri Metro's electric service area.

THE COMMISSION ORDERS THAT:

- 1. Any party to File No. EO-2015-0240 shall be a party to this by filing a notice of intention to participate no later than December 13, 2019.
 - 2. Any applications to intervene shall be filed no later than December 13, 2019.
- 3. The Commission's Data Center shall serve a copy of this order upon each of the parties to File No. EO-2015-0240.
- 4. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the electric service territory of Evergy Metro, Inc., d/b/a Evergy Missouri Metro.
- 5. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the electric service area of Evergy Metro, Inc., d/b/a Evergy Missouri Metro, and to the news media serving the residents of the electric service territory of Evergy Metro, Inc., d/b/a Evergy Missouri Metro.
- 6. The Commission's Staff shall file its recommendation no later than January 1, 2020.

7. This order shall be effective when issued.
