## CORRECTED<sup>1</sup> PROTECTIVE ORDER

The Missouri Public Service Commission is granting the *Motion for Protective*Order<sup>2</sup> ("motion") filed by Entergy Arkansas, Inc.

The Commission's confidentiality regulation allows greater protections on the filing of a motion describing the information at issue and the grounds for greater protection, including possible harm from disclosure.<sup>3</sup> The motion alleges that the information is commercially sensitive and asks for protections parallel to those provided by the Arkansas Public Service Commission ("APSC"), where the information is under the APSC's protections in a pending action. Such greater protections would not alter the access to information of the Commission's staff and the Office of the Public Counsel already provided by law.

Therefore, the Commission will grant the motion and incorporate the provisions for greater protection as proposed in the motion by reference as if fully set out in this order.
