**ORDER CANCELING HEARING AND
SUSPENDING PROCEDURAL SCHEDULE**

On October 10, 2018, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri), on behalf of all the parties¹ to this matter filed a request to suspend the procedural schedule pending the filing of a settlement agreement. Ameren Missouri reports that an agreement has been reached in principle to which all the parties either agree or have indicated they will not object. The parties requested that the procedural schedule, including the hearing set to begin October 15, 2018, be suspended to allow them time to commit their agreement to writing and file it with the Commission.

The Commission will grant the motion, cancel the hearing, and suspend the remaining procedural schedule. The Commission will also direct the parties to file their written agreement or a status report stating when such an agreement will be filed as directed below.

THE COMMISSION ORDERS THAT:

1. The hearing set for October 15-19, 2018 is canceled.
2. The remaining portions of the procedural schedule are suspended until

further order of the Commission.

3. No later than October 19, 2018, the parties shall either file their written agreement or a status report stating when an agreement is expected to be filed.
