The parties have submitted four partial stipulations and agreements to resolve various issues regarding Union Electric Company d/b/a Ameren Missouri's request for a general rate increase for its electric and natural gas service. Those stipulations and agreements are as follows:

- Filed December 6, 2021, in ER-2021-0240, *Second Unanimous Stipulation and Agreement*.
- Filed December 3, 2021, in GR-2021-0241, *Stipulation and Agreement Regarding MSBA Issues*.
- Filed December 3, 2021, in GR-2021-0241, a *Unanimous Stipulation and Agreement*.

The Commission will schedule an on-the-record presentation for the parties to have the opportunity to present the stipulations and agreements and to answer any Commission questions concerning the stipulations and agreements.
