ORDER CANCELING IVOIP REGISTRATION

Issue Date: November 2, 2022 Effective Date: December 2, 2022

On October 19, 2022, Verge Network Solutions, Inc. notified the Commission that it wishes to cancel its authority to provide interconnected voice over internet protocol (IVoIP) service in Missouri. The Commission granted that registration in File No. DA-2019-0256, on March 18, 2019.

The Commission directed its Staff to respond, and on November 2, 2022, Staff filed a recommendation advising the Commission to cancel Verge Network Solutions' registration.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's recommendation, the Commission finds that the registration granted to Verge Network Solutions shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The registration to provide IVoIP services granted to Verge Network Solutions in File Number DA-2019-0256 is canceled.
 - 2. This order shall become effective on December 2, 2022.

3. This file may be closed on December 3, 2022.
