## **Application to Abandon Certificate**

DelTel, Inc. ("DelTel"), pursuant to Case No. XA-2005-0176, Tariff No. JX-2008-0104, respectfully requests that the Missoui Public Serice Commission ("Commission") allow DelTel to voluntarily surrender its certification, without prejudice, to provide interexchange service within the State of Missouri ("IXC Certification") and, to the extent necessary, cancel its Missouri tariff currently on file with the Commission.

Applicant's legal name is DelTel, Inc. Applicant is a public utility corporation formed under the laws of the State of California. In the State of Missouri, DelTel is authorized to provide resold interexchange telecommunications services granted in Order Case No. XA-2005-0176, Tariff No. JX-2008-0104 issued in Missouri on 1/16/2007. DelTel requests that its IXC Certification be canceled immediately or as soon as the Commission can take any necessary administrative action.

### 2. Circumstances Requiring Voluntary Surrender of Certificate

Due to natural attrition, DelTel, Inc. no longer has Telecommunication Customers in Missouri and therefore, no longer requires its authorizations. Because DelTel no longer serves any telecommunication customers in Missouri and neither holds deposits nor advance payments from any Missouri consumers, DelTel respectfully submits that the surrender of its authorizations is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.

To the extent necessary, DelTel also withdraws, and requests cancellation of, its Missouri tariff currently on file with the Commission. DelTel submits that the surrender of its IXC Certification and, to the extent necessary, the withdrawal of its tariff are reasonable, necessary and not disruptive to the present or future public interest, convenience and necessity of Missouri.

#### 3. Description of Arrangements to Pay Amounts to the Commission

To the extent that DelTel has any outstanding taxes, fees, or other amounts owed to the Commission, those taxes, fees, or other amounts, DelTel will promptly pay any amounts owed the Commission or any other agency of the State.

#### 4. Plan for Facilities in Missouri

DelTel submits that it does not have any facilities in Missouri, and therefore, the requirement to propose a plan to remove, maintain, or transfer facilities is inapplicable.

#### 5. Verification
