COMES NOW the Office of the Public Counsel and, having filed its notice of appeal to the Missouri Western District Court of Appeals without the Commission-approved “detailed reconciliation containing the dollar value and rate or charge impact of each contested issue decided by the commission,” that § 386.510, RSMo, requires, Public Counsel requests the Commission to “cause to be prepared, with the assistance of the parties to such proceeding, and [to] approve, after allowing the parties a reasonable opportunity to provide written input, a detailed reconciliation containing the dollar value and rate or charge impact of each contested issue decided by the commission” as required by § 386.420.4, RSMo., so that Public Counsel can supplement its notice of appeal to comply with § 386.510, RSMo.
