**STAFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through the undersigned counsel, and submits its *Recommendation* as follows:

1. On August 21, 2019 the Commission issued its *Order Rejecting Fuel Adjustment Clause Tariff, Scheduling a Procedural Conference and Directing the Filing of a Revised Tariff*, with an effective date of August 31, 2019.

2. KCP&L Greater Missouri Operations Company ("GMO") was ordered to file tariff sheet(s) that same day to implement interim fuel adjustment rates to reflect any part of a proposed adjustment not in question.

3. GMO filed a Second Substitute Tariff Sheet to implement interim adjusted fuel adjustment rates, removing the cost of auxiliary power GMO used for its steam operations at its Lake Road station and removing the costs of coal and propane at the retired Sibley generation facility, amounts that were contested by the Office of the Public Counsel.

4. Following GMO's filing of the Second Substitute Tariff Sheet on August 21, 2019, the Commission ordered Staff and any other party wishing to do so to file a recommendation no later than August 23, 2019.

5. After reviewing GMO's Second Substitute Tariff Sheet and the accompanying workpapers, Staff has verified that GMO correctly removed the disputed amounts, and recommends that the Commission issue an order indicating the following proposed Second Substitute Tariff Sheet will take effect by operation of law on September 1, 2019:

**WHEREFORE**, Staff recommends the Commission issue an order indicating the 1st Revised Sheet No. 127.23, as substituted August 21, 2019, become effective on September 1, 2019 by operation of law.



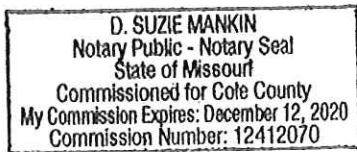


