## ORDER GRANTING MOTION TO SUSPEND PROCEDURAL SCHEDULE AND DIRECTING FILING

On April 21, 2023, the Office of the Public Counsel (OPC) filed a motion on behalf of all parties to suspend the procedural schedule. The motion states that the parties are engaged in ongoing settlement negotiations and anticipate filing a Stipulation as soon as is reasonably practicable.

The Commission finds the unanimous request reasonable and will grant the motion to suspend the procedural schedule. The Commission will cancel the currently set evidentiary hearing and order a status report.

- 3. The parties shall file a copy of any agreement reached or a status report on this matter no later than June 5, 2023.
