**ORDER SETTING PROCEDURAL CONFERENCE**

On March 27, 2023, Union Electric Company d/b/a Ameren Missouri applied to the Commission for approval of a Missouri Energy Efficiency Investment Act (MEEIA) plan. The Commission convened a prehearing conference for the parties to discuss scheduling.

On May 2, 2023, the parties filed a Joint Request for an Extension of Time to File a Procedural Schedule or Status Report by May 22, 2023 (Joint Request). In the Joint Request, the parties explain that they will hold technical conferences on May 10 and 11, 2023, and that they expect to hold additional conferences. Thus, the parties believe they can file a procedural schedule or status report by May 22, 2023.

The Commission finds the request reasonable, and will grant it.

**THE COMMISSION ORDERS THAT:**

1. The Joint Request is granted.
2. The parties shall file a procedural schedule or a status report no later than May 22, 2023.
3. This order shall be effective when issued.
