On January 4, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively "Evergy") filed a request asking the Commission to grant it a variance from 20 CSR 4240-22.080. Specifically, Evergy seeks to delay its next required annual resource plan update filing from March 2023, until June 15, 2023.

On January 12, 2023, Dogwood Energy LLC filed an application to intervene. Ten days have elapsed, and no party has objected to the application to intervene.<sup>1</sup> The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075, and is in the public interest. Intervention will be granted.

# THE COMMISSION ORDERS THAT:

- 1. Dogwood Energy LLC's application to intervene is granted.
- 2. This order is effective when issued.
