## ORDER GRANTING APPLICATION TO INTERVENE

On April 14, 2023, Union Electric Company d/b/a Ameren Missouri filed its 2022 Renewable Energy Standard (RES) Compliance Report and its 2023-2025 Annual RES Standard Compliance Plan, as required by Commission Rule 20 CSR 4240-20.100(8). On May 1, 2023, the Missouri Department of Natural Resources – Division of Energy (DE) filed a timely application to intervene. More than ten days have passed since DE applied to intervene and no party has responded to that application.<sup>1</sup>

Commission Rule 20 CSR 4240-2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The Commission finds that allowing DE to participate will serve the public interest. The Commission will grant the application to intervene.

### THE COMMISSION ORDERS THAT:

1. The Application to Intervene of the Missouri Department of Natural Resources – Division of Energy is granted.
