## ORDER DIRECTING RESPONSES

Issue Date: July 15, 2021

Effective Date: July 15, 2021

On April 15, 2021,<sup>1</sup> Evergy Missouri West, Inc. filed its 2021 Renewable Energy Standard Compliance Plan (Compliance Plan). On June 22, the Staff of the Missouri Public Service Commission (Staff) filed its report indicating that Evergy Missouri West had met the statutory and rule requirements. In response to Staff's report, Evergy Missouri West filed a revised Compliance Plan (Revised Compliance Plan) on July 7.<sup>2</sup>

Also on July 7, the Office of the Public Counsel (OPC) made several recommendations that the Commission order more detailed information from Evergy Missouri West regarding certain items. The July 7 response seeks identification of which non-solar renewable resources are directly attributable to RES compliance and all costs for each of its non-solar RES and economic renewable resources. OPC also notes three errors including purchase power agreements included in error and a reversal of the estimated energy for two purchase power agreements.<sup>3</sup>

The Commission will direct the Evergy Missouri West to respond to OPC's comments.
