ORDER DIRECTING STAFF TO FILE DISCOVERY RESPONSE

Issue Date: July 21, 2022 Effective Date: July 21, 2022

On June 6, 2021, the Staff of the Commission (Staff) filed rebuttal testimony of witness Cynthia Tandy. Ms. Tandy stated that Evergy Missouri West provided its Annual Valuation Procedures review in response to Staff Data Request No. 0056 (DR 56).¹ DR 56 reads as follows: "For the period January 1, 2020 through June 30, 2021, did the Company have a policy or written plan on how to handle RECs [Renewable Energy Credits]? If yes, please provide the Company's REC policy/plan in electronic format."²

In order to aid in its preparation for the upcoming hearing scheduled for July 27-28, 2022, the Commission will order Staff to file in the Commission's Electronic Information Filing System (EFIS) the response to DR 56.
